#### **ORDER:**

In the Government Order first read above, orders were issued among others revising the Fixed Pay of the Chairman, Tamil Nadu Public Service Commission from Rs.26,000/- to Rs.80,000/- notionally w.e.f 01.01.2006 and with monetary benefit from 01.01.2007.

2. In the Government Order second read above, orders were issued revising pay scale of the All India Administrative Service Officers w.e.f 01.01.2016 based on the recommendations of the Seventh Central Pay Commission.

3. In the letter third read above, the Chairman, Tamil Nadu Public Service Commission has requested to fix his pay w.e.f 01.01.2016 based on the orders issued in the reference second cited.

4. After careful consideration, Government has decided to revise the pay of the Chairman, Tamil Nadu Public Service Commission based on the recommendations of Seventh Central Pay Commission. Accordingly, Government direct that the pay of the Chairman, Tamil Nadu Public Service Commission be revised from Rs.80,000/- to Rs.2,25,000/- w.e.f. 01.01.2016.

5. Necessary amendment to the Tamil Nadu Public Service Commission Regulations, 1954 will be issued separately.


