### **ORDER:-**

The NABARD Consultancy Services Pvt. Ltd has forwarded the offer of services for NABARD Project Monitoring Unit in Finance Department in State of Tamil Nadu

2. The Government have proposed to engage the Consultancy Services of the NABARD Consultancy Services Pvt. Ltd by according exemption under section 16 (bb) of Tamil Nadu Transparency in Tenders Act (2<sup>nd</sup> Amendment Act.) 2018 for operationalizing NABARD Project Monitoring Unit in Finance Department to actively follow up proposals pending with NABARD, monitor the implementation of sanctioned projects on the field & expedite the disbursement of funds, with the objective of effective implementation of NABARD projects .

3. Accordingly, a committee comprising of the following members was constituted as envisaged in section 16 (bb) of Tamil Nadu Transparency in Tenders Act, (2<sup>nd</sup> Amendment), 2018 for recommendations on engaging the said firms as consultant

4. The Committee, in the meeting held on 24.05.2022, discussed the importance of setting up and operationalizing "NABARD Project Monitoring" Unit in Finance Department and examined the expression of interest submitted by the NABARD Consultancy Services Pvt. Ltd.

5. The committee therefore commended to engage the NABARD Consultancy Services Pvt. Ltd (NABCONS) as "Consultants" for setting up and operationalizing of a "NABARD Project Monitoring Unit" in Finance Department to actively follow up proposals pending with NABARD, monitor the implementation of sanctioned projects on the field & expedite the disbursement of funds, with the objective of effective implementation of NABARD projects by exempting it from Tamil Nadu Transparency in Tenders Act 1998 by invoking Section 16 (bb) of Tamil Nadu Transparency in Tenders ( Second Amendment) Act 2018.

After careful examination, the Government decided to issue ratification orders for having constituted the committee as indicated at para 3 above and also accept the recommendation of the said committee for engaging the NABARD Consultancy Services Pvt. Ltd(NABCONS) as "Consultants" for setting up and operationalizing of a "NABARD Project Monitoring Unit" in Finance Department to actively follow up proposals pending with NABARD, monitor the implementation of sanctioned projects on the field & expedite the disbursement of funds, with the objective of effective implementation of NABARD projects etc by according exemption under section 16(bb) of Tamil Nadu Transparency in Tenders Act ( 2<sup>nd</sup> Amendment) ,2018 and issues orders accordingly.

7. Necessary notification required under section 16 (bb) of Tamil Nadu Transparency in Tenders Act (2<sup>nd</sup> Amendment) , 2018 will be issued separately by Finance ( Salaries).
