ORDER:

In the Government Order first read above, an Expert Committee was constituted under Tmt. Santha Sheela Nair, IAS (Retd), with a term of four months, to examine the feasibility of implementing the demand to continue old pension scheme and make necessary recommendations on the possible options to Government. In Government Orders second to fourth read above, the term of the Expert Committee was extended further upto 25.03.2017. In the meantime, Tmt. Santha Sheela Nair, Chairperson, in her letter fifth read above, has informed about her resignation due to personal reasons, which was duly accepted by the Government.

2. In order to continue the work of the Expert Committee, the Government, after careful consideration, appoint Dr. T. S. Sridhar, IAS (Retd), as Chairperson of the Expert Committee and extend the term of the

committee upto November, 2017, so as to enable the committee to continue and complete the task assigned to it.
