Sub: Official Committee on Revision of Pay and Allowances, 2017 - Particulars of Posts and Scales of Pay / Special Pay and Allowances - Called for - Regarding.

I am to invite attention to the reference cited wherein the Government has constituted an Official Committee to examine and make necessary recommendations for the implementation of the revision of scales of pay and allowances of State Government Employees and Teachers including employees of Local Bodies based on the decisions of the Central Government on the recommendations of the Seventh Central Pay Commission and the High Level Committee constituted for allowances and also revision of pension, family pension and retirement benefits.

- 2. The updated consolidated particulars of the Posts and Scales of Pay with post-wise number of employees / Special Pay and Allowances for all departments are required for the Official Committee. Hence, I am to enclose the format of the details of the Posts and Scales of Pay pertaining to your department in Annexure-I for furnishing the following particulars:
 - The post-wise number of employees including employees in Special Time Scales of Pay / Consolidated Pay / Fixed Pay and Honorarium (i.e. sanctioned strength, persons in position & vacancies) (both permanent / temporary) as on 1-5-2017.

- The number of persons under different grades as per House Rent Allowance eligibility.
- The number of persons retiring during the years 2017-2018 to 2020-2022 and

While furnishing the above said details, authority concerned is to ensure the correctness of the Scales of Pay corresponding to the Ordinary Grade post only.

- **3.** I am also to enclose the format of the details of the Posts and Scales of Pay pertaining to your department in Annexure-II for furnishing the post wise number of employees drawing Special Pay and Allowances.
- **4.** The Heads of Department are requested to obtain necessary particulars from their subordinate offices in detail and then consolidate the information for the department as a whole, in the formats annexed to this letter.
- 5. In respect of local body employees those who are drawing their pay from the local body fund, the concerned Heads of Department shall obtain the necessary particulars from their respective local bodies in detail and then consolidate the information for the Village Panchayats / Panchayat Unions / Town Panchayats and Panchayat Townships / Municipalities / Municipal Corporations as a whole, in the formats annexed to this letter.
- **6.** The Administrative Departments of Secretariat and the Heads of Department shall obtain the Standard Excel Worksheets for the Posts and Scales of Pay / Special Pay and Allowances format from the Office of the Official Committee, Finance Department, Secretariat, Chennai-9. After filling up the data, the hard and soft copies of the particulars of Posts and Scales of Pay / Special Pay and Allowances be handed over to the Office of the Official Committee in person.
- 7. The Official Committee has been asked to submit its report to Government within four months i.e. on or before 30-06-2017. It is therefore imperative that the above said particulars of the Posts and Scales of Pay / Special Pay and Allowances reach the Official Committee latest on or before 31st May, 2017. I hope you appreciate the importance and urgency of the whole exercise and ensure that the stipulated deadline is adhered to scrupulously.
