**ORDER:**

In the Government Order first and second read above, orders were issued for implementation of the Integrated Financial and Human Resources Management System (IFHRMS) Project, whereby all human resources and financial activities of the Government are to be carried out online.

2. In the Government Order third read above, orders were issued for enabling the Pensioners to receive their first Pension and Commuted Value of Pension, either in Person or through e-mustering in Jeevan Praman Portal as per the option of the Pensioner.

3. Accordingly, the Commissioner of Treasuries and Accounts has proposed for amending Treasury Rule 16, Subsidiary Rule 65 (a) (1) of the Tamil Nadu Treasury Code Volume-I.

4. The Government, after careful examination, has decided to accept the proposal of Commissioner of Treasuries and Accounts and issue the following notification:-

**NOTIFICATION**

In exercise of the powers conferred by Article 283 (2) of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Treasury Rule 16, Subsidiary Rule 65 (a) (1) of the Tamil Nadu Treasury Code Volume-I.

The amendment hereby made shall be deemed to have come into force with effect from 26.02.2020.

**AMENDMENT**

In the said Tamil Nadu Treasury Code, Volume-I, in Subsidiary Rule 65 (a) (1) under Treasury Rule 16, the following shall be substituted:-

"As a rule except in the case of provisional pension payable through a Head of Office, a pensioner who is receiving first pension based on the issue of e-authorization by the Accountant General shall either take the pension in person or through Jeevan Praman Portal (e-mustering) and the disbursing officer shall identify the pensioner with reference to the details available in the pension payment order before making any payment. The pensioner need not be required to produce a copy of the order (i.e) Accountant General authorization at the Pension Pay Office/District Treasury/Sub-Treasury Office in which the pension drawn and the Pension Pay Officer/District Treasury Officer/Assistant Treasury Officer/Sub-Treasury Officer should not insist the pensioner to produce a copy of the order communicating the sanction of the pension".
