

### **ABSTRACT**

Post sanction – Further Continuance of Temporary Posts beyond ten years – Constitution of a Committee to examine the need for continuing temporary posts – Orders - Issued.

### ORDER:

Posts are created temporarily in Government Departments in exceptional cases for a specified period. Most of such temporary posts are allowed to continue for years together pending further continuance to be issued by the administrative Departments of Secretariat till the incumbent vacates the post or the purpose for which the post has been created ceases.

- 2. In the Government Letter read above, fresh guidelines were issued to regulate the proposal referred to Staff Committee for creation of posts.
- 3. In the reference second and third read above, considering the prevailing situation of Covid-19 in the State and the compelling need to regulate expenditure, a total ban on creation of new posts in all Departments has been imposed. However, recruitment against existing entry level vacant posts including compassionate ground appointment has been allowed to continue. In cases where the posts are vacant for more than 3 years, approval of the Staff Committee shall be obtained for revival of the posts prior to filling them up.
- 4. The proposals for continuing temporary posts beyond the sanction period are often received belatedly and the temporary posts are utilised without further continuance and the pay and emoluments for the posts are claimed every month based on pay authorization resulting in receipt of vast number of files from all Departments of Secretariat. The proposals seeking continuance of temporary posts has to be examined in detail, after taking into account the purpose for which the posts were created and the need to continue the posts beyond the sanction period.
- 5. The posts which are kept vacant for more than five years may no longer be required for the purpose for which they were created and allowing them to continue

for further period serves no purpose. The need for such vacant posts for more than five years also needs examination.

- 6. There is an imperative need to review the posts which are vacant for more than five years and continuance of the temporary posts beyond ten years.
- 7. Accordingly, the Government direct that a Committee shall be constituted comprising the following Officers to accomplish the objective.
  - i. Secretary to Government concerned
  - ii. Head of the Department concerned
  - iii. Officer nominated by the Additional Chief Secretary, Finance Department

The Committee may include a representative of Human Resources Management Department as a special invitee.

- 8. The terms of reference of the Committee and the Officers in the Committee are annexed as Annexure-I and II to the Government Order.
- 9. Based on the recommendation of the Committee, the need to continue the posts as temporary or otherwise beyond ten years of their creation and posts which are vacant for more than five years will be considered by Government.

# **ANNEXURE - I**

# TERMS OF REFERENCE OF THE COMMITTEE

- 1. The Committee shall:
  - a) Examine the purpose for which the temporary posts were originally sanctioned;
  - b) Ascertain whether, as of now, these posts are utilized for the same purpose or being utilized for some other purposes;
  - c) Examine and recommend the need to continue the temporary posts beyond ten years with justification/norms/modification if any and the same should be recorded;
    - Recommend whether the temporary posts can be made permanent if the need for the post exists perennially;
  - d) Explore the possibility of abolishing the posts, if not necessary;
  - e) Identify redundant posts;
  - f) Review the posts which are vacant for more than five years;
- 2. The Committee shall submit its report to Government within a period of six months.
