ORDER :

In the Government Orders read above 27 posts of Foreman Instructor were sanctioned to the newly created Polytechnic Colleges. In the letter twelfth read above, the Commissioner of Technical Education has sent proposal to Government for framing of Adhoc Rules for the post of Foreman Instructor in Government Polytechnic Colleges other than in Special Institutions.

2. The post of Foreman Instructor in Government Polytechnic Colleges (other than in Special Institutions) be brought under the purview of the Tamil Nadu Public Service Commission. Necessary amendments to the Tamil Nadu Public Service Commission Regulations, 1954 will be issued separately by the P&AR (M) Department.

3. The Government also direct that the said post be classified as "Technical" for the purpose of direct recruitment. The Tamil Nadu Public Service Commission in the reference 14th cited agreed to the proposal of the Government for framing of Adhoc Rule to the above said post.

4. The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following Rules:-

RULES

The provisions contained in the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) and the Special Rules applicable to the holders of the permanent posts of Foreman Instructor in category 2 of class III in the Tamil Nadu Technical Educational Subordinate Service, shall apply to the holders of the temporary post of Foreman Instructor in the Government Polytechnic Colleges (other than in Special Institutions) sanctioned from time to time, in the Department of Technical Education, subject to the modifications specified in the following rules:-

- (2) **Constitution.**- The post shall constitute a separate category in a distinct class of the said Service.
- (3) **Appointment.**- Appointment to the post shall be made as follows:-
 - (i) Promotion from Workshop Instructor in Government Polytechnic Colleges and Special Institutions;
 - (ii) If no qualified and suitable candidates are available for appointment by method (i) above then by direct recruitment.
- (4) **Appointing Authority.**- The appointing authority for the post shall be the Additional Director of Technical Education (Polytechnics).
- (5) **Qualifications.**-
 - a) **Age.**- No person shall be eligible for appointment to the post by direct recruitment, if he has completed or will complete 36 years of age on the first day of July of the year in which the vacancy is notified.
 - b) **Other Qualifications.**- No person shall be eligible for appointment to the post unless he possesses the following qualifications, namely:-
 - (i) (a) A Diploma in any branch of Engineering / Technology;
and
 - (b) Practical experience for a period of not less than one year in a recognized Workshop / Lab;

(or)

 - (ii) (a) An Industrial Training Institute Certificate / National Trade Certificate / National Apprenticeship Training Certificate in any trade; and
 - (b) Practical experience for a period of not less than five years in a recognized Workshop / Lab.

* **Explanation:**

“ A Recognised Workshop or Factory” means a Workshop or Factory satisfying the definition of Factory in section 2(m) of the Factories Act, 1948 (Central Act LXIII of 1948) and includes a Workshop or Laboratory attached to a Technical Educational Institution. Hence, if candidates have practical experience in Factory, then the experience Certificate should be obtained from Head of the Factory and if candidates have practical experience in Workshop or Laboratory in Technical Educational Institutions, then the experience certificate should be obtained from the Principal of the Concerned Institution”

- (6) **Reservation of Appointments.**- The Provisions contained in section 27 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) shall apply for appointment to the post by direct recruitment.
- (7) **Probation.**- Every person appointed to the post by direct recruitment shall, from the date on which he joins duty, be on probation for a total period of two years, on duty within a continuous period of three years.
- (8) **Pay.**- The holders of the post shall be paid a monthly pay calculated in the level pay of Rs.35,400-1,12,400.
