

Technical Education – Sports Quota – Enhancement of seats from 100 to 500 in Engineering Colleges – Orders – Issued.

ORDER:

In the Government Order first read above, Government have issued orders for admission to the Engineering Colleges for the year 2003-2004, within the reservation contemplated by Tamil Nadu Act 45 of 1994:-

(i)	Physically handicapped		3%
(ii)	Eminent Sports Persons (International/National/State Level Participations)	•	42 seats
(iii)	Children of Freedom Fighters	•	10 seats
(iv)	Children of Ex-servicemen	:	81 seats

2. In the Government Order second read above, Government have issued orders for enhancement of reservation of seats under Eminent Sports Persons category from 42 to 100. Following this order, from the year 2008-2009 to 2011-2012, 100 seats were reserved under Eminent Sports Persons category. The 100 seats were distributed in the following proportion during 2011-2012:-

(i)	University Departments of Anna University, Chennai – 25	:	12 seats
(ii)	Government Engineering Colleges	·	6 seats
(iii)	Government Aided Engineering Colleges	;	3 seats
(iv)	Constituent Colleges of Anna Universities of Technology		14 seats
(v)	Self Financing Engineering Colleges	:	65 seats
(V)	Total	:	100 seats

- 3. In the letter third read above, the Commissioner of Technical Education requested the Government to consider the request of the Member Secretary, Sports Development Authority of Tamil Nadu to increase the number of seats reserved under Eminent Sports Persons quota from 100 to 500 seats from the academic year 2012-2013 onwards.
- 4. The Government examined the proposal in detail and decided to accept the same and to enhance the seats reserved under Eminent Sports Persons category from the existing 100 to 500 seats from the year 2012-2013 onwards subject to the following conditions:-
- (i) Seats under Eminent Sports persons quota shall be allocated as follows:

University Departments of Anna University, Chennal – 25 comprising College of Engineering Guindy (CEG), Madras Institute of Technology, Chrompet (MIT), Alagappa College of Technology (ACT) and School of Architecture and Plancing (SAP)	12 seats
Government / Government Aided / Self Financing / Constituent Colleges of Anna University*	500 – 12 = 488 seats at the rate of one seat per college

* Exact number of seats allocation not shown separately categorywise due to the fact that number of Government / Constituent colleges may vary year after year consequent to the decision taken by the Government for opening new Government Engineering Colleges.

- (ii) The above seats shall be reserved within Government quota seats for single window counselling.
- (iii) The above seats shall be distributed among the various categories of Colleges following Rule of reservation.
