#### **ORDER:-**

In the letters second read above, the Director of Technical Education has requested an amendment order for rule 5 of the Tamil Nadu Admission in Engineering Institutions Rules, 2007 issued in the Government Order first read above, in order to reduce the usage of random numbers and to increase the fairness of fixing the Inter-se-merit based on the students academic performance, for the welfare of the students towards conducting the online counseling for Tamil Nadu Engineering Admission from the academic year 2021-22 onwards as specified below:-

<u>Determination of Inter-se-merit.-</u> In cases where more than one student have got the same marks in the common merit list, the inter-se-merit among such students shall be determined in the order of priority as specified below:-

- (i) percentage of marks in Mathematics
- (ii) percentage of marks in Physics
- (iii) percentage of total marks in 12<sup>th</sup> Standard Examination
- (iv) percentage of marks in the optional subject
- (v) percentage of total marks in 10<sup>th</sup> Standard Examination
- (vi) date of birth
- (vii) random number assigned

2. The Government after careful examination, have decided to amend rule 5 of the Tamil Nadu Admission in Engineering Institutions Rules, 2007. The following Notification will be published in the Tamil Nadu Government Gazette Extraordinary:-

### NOTIFICATION .

In exercise of the powers conferred by sub-section (1) of section 10 of the Tamil Nadu Admission in Professional Educational Institutions Act, 2006 (Tamil Nadu Act 3 of 2007), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Admission in Engineering Institutions Rules, 2007.

## AMENDMENT .

In the said Rules, for rule 5, the following rule shall be substituted, namely:-

" 5. Determination of Inter-se-merit.- In cases where more than one student have got the same marks in the common merit list, the inter-se-merit among such students shall be determined in the order of priority as specified below:-

- percentage of marks in Mathematics. (i)
- (ii) percentage of marks in Physics.
- percentage of marks in the optional subject. (iii)
- percentage of total marks in the qualifying examination. (iv)
- percentage of total marks in X Standard examination. (v)
- date of birth. (vi)
- random number assigned.". (vii)
