ORDER:-

In the letter second read above, the Member Secretary, Tamil Nadu State Council for Higher Education, has forwarded the resolution passed by the Chairpersons, Board of Studies-Commerce held on 16.9.2022 and subsequently approved by the Chairman, Equivalence Committee / the Principal Secretary to Government, Department of Higher Education, that the degree B.Com (Corporate Secretaryship - Direct III Year), awarded by University of Madras to Tmt.P.Poorkodhy, enrolled during the academic year 2011-2012 (bearing Register No./Enrolment No.A9102UCR6282), is **Not Equivalent** to B.Com for the purpose of employment in Public Services and requested the Government to issue orders in the matter.

2. The Government, after careful consideration, accept the recommendation of the Chairpersons, Board of Studies-Commerce, constituted by the Tamil Nadu State Council for Higher Education, on 16.9.2022, duly approved by the Chairman, Equivalence Committee / the Principal Secretary to Government, Department of Higher Education and direct that the following Degree offered by the University of Madras be not equivalent to the Degree mentioned therein:-
