

Technical Education – Internship to the students from Government Engineering Colleges and Government Polytechnic Colleges (10,000 students per year) with financial support at the rate of Rs.16,600/- per student to train them for 25 days to enhance their technical skills – Selection criteria – Orders – Issued.

ORDER:

The Government, in the Government Order first read above, accorded administrative sanction for a sum of Rs.16,60,00,000 /- to the Director of Technical Education for Internship to the Engineering and Polytechnic College students towards Financial support at the rate of Rs.16,600/- per candidate to train students for 25 days to enhance the technical skill of the students covering 10,000 students for every year from Government Polytechnic Colleges and Government Engineering Colleges and subject to the condition that in case of any additional expenditure required more than Rs.16,600/-, the same will have to be borne by the students only.

2. The Director of Technical Education in her letter second read above, has stated that All India Council for Technical Education (AICTE) has come up with new Internship policy that mandates Internship spanning 4-8 weeks as part of UG Engineering Courses and Diploma courses. In the manual given by AICTE, for guidelines and Procedures to Internship, it is mentioned that "It is proposed to give Academic Credit for the Internship undergone as part of the Programme. A minimum of 14-20 credits of Internship / Entrepreneurial activities will be counted toward 4 year Engineering Degree Programme and 10-14 credits for 3 year Diploma Programme across the country. One Credit is equivalent to 40-45 hours of work. Therefore Opportunities must be provided for experiences that cannot be anticipated when planning the course". In the Government Order first read above, it is stated that out of 10,000 students, a total of 2,500 Top Ranking Students who completed their Third Year course of study will be selected from all Government Engineering Colleges and 7,500 Top Ranking students who completed their second year course of study will be selected from all Government Polytechnic Colleges. The Director of Technical Education has further stated that the Top Ranking Students are capable of getting Good Job after Graduation. Many students studying in Government Institutions hail from the following environment:-

- i. Rural Background
- ii. Single or No Parent
- iii. Low Annual Income to meet the daily routine needs.
- iv. First Graduate etc.

In addition to considering only the Academic Performance of the Students, if the above Parameters are also considered for Selection of 10,000 students every year from Government Engineering Colleges and Government Polytechnic Colleges, the Socially and Economically affected community throughout the State will be benefitted with the above scheme. She has requested orders that the Selection Criteria for B.E / B.Tech students and for Diploma students shall be changed as per Table-I and Table-II respectively as detailed below:
