

Technical Education – Announcement 2020-21 - Administrative and Financial Sanction for the Establishment of office of the Regional Joint Director at Madurai for Directorate of Technical Education – Creation of posts and financial sanction of Recurring expenditure – Orders – Issued.

2. From the Director of Technical Education Letter No.6922/ H3/2020, dated 20.03.2020 and 30.11.2020.

ORDER:

During the Budget Session 2020-21, the Hon'ble Minister for Higher Education has made the following Announcement on 12.03.2020 in the Tamil Nadu Legislative Assembly:-

- 2. For implementing the above Announcement, in the letter second read above, the Director of Technical Education has sent the proposal for consideration of the Government:-
 - (i) The Directorate of Technical Education was established during the year 1957. There are 1071 institutions including 564 Engineering Colleges (excluding 20 Anna University Colleges) and 507 Polytechnic Colleges and Hotel Management and Catering Technology institutions under the control of Directorate of Technical Education. In line with the functioning of Regional Joint Director Offices under Directorate of Collegiate Education, it is proposed to establish similar Regional Joint Director Offices in Madurai with the sole objective for effective monitoring and special focus on academic activities under Directorate of Technical Education, Chennai. The Directorate of Technical Education is administering 10 Government Engineering Colleges and 51 Government Polytechnic Colleges and 3 Government Aided Engineering Colleges and 34 Government Aided Polytechnic Colleges.
 - (ii) In addition to the above, DOTE has to monitor the 551 Self Financing Engineering Colleges and 418 Self Financing Polytechnic Colleges and Hotel Management Institutions throughout the State of Tamil Nadu and also conducting Typewriting, Shorthand and Office Automation Examination twice in a year and around 3000 Typing Centres are recognized by Directorate of Technical Education and monitoring of its

functioning. Hence establishing Regional Joint Director office at 6 regions is essential. However as a pilot scheme, it is proposed to establish one Regional Joint Director office at Madurai for effective monitoring /implementation of all Departmental activities.

- (iii) The Proposed Regional Joint Director office at Madurai will facilitate effective monitoring and for giving special focus to academic activities, placement activities, industry-academia interface activities and internship training to the students in Engineering and Polytechnic colleges and also to monitor and conduct all typing / shorthand / office automation examinations as well as to monitor 202 Engineering colleges and 228 Polytechnic colleges in the Madurai Region and also to monitor the court cases in Madurai High Court.
- (iv) In order to enhance the quality of Education in all Technical Institutions in Tamil Nadu, it is felt very much essential for effective monitoring and special focus on academic activities. Works to be entrusted to Regional Office and the number of Engineering and Polytechnic Colleges coming under the control of Proposed Madurai Regional Joint Director Office are furnished.
- 3. In the letter second read above, the Director of Technical Education has also furnished the following particulars to the Government for consideration:-
 - The staff structure for the proposed Office of the Regional Joint Director at Madurai is given below:
 - Joint Director(In the cadre of Principal of Engineering College)
 - Deputy Director(In the cadre of HOD Polytechnic)
 - 3 Deputy Director (In the cadre of Associate Professor)
 - 4 Assistant Director
 (In the cadre of Lecturer of Polytechnic)
 - 5 Assistant
 - 6 Typist
 - 7 Office Assistant
 - 8 Sanitary Worker (Outsourcing)
 - One post of Joint Director, two posts of Deputy Directors and one post of Assistant Director will be filled up by the recruitment by transfer.
 - The posts of Assistant, Typist and Office Assistant will be filled up by deputation.
 - The post of Sanitary Worker will be filled up by outsourcing.
 - There is no surplus post or vacant post in Technical Education Department.
 - If the post of Sanitary Worker will be filled up by outsourcing, the pay will be fixed as Rs.1.80 lakh per annum.

- 4. In the letter second read above, the Director of Technical Education has requested the Government to accord necessary sanction order for the Establishment of Office of the Regional Joint Director at Madurai and also sanction a sum of Rs.111.32 lakh towards recurring expenditure for creation of 8 posts for the above office.
- 5. The Government after careful examination of the proposal of the Director of Technical Education, have decided to accept it and to accord Administrative and Financial sanction for the establishment of Office of the Regional Joint Director at Madurai for Directorate of Technical Education, and also accord sanction for 8 posts as detailed in the Annexure to this order and also sanctioned a sum of Rs.26,01,356 /- (Rupees Twenty six lakh one thousand three hundred and fifty six only) as Recurring Expenditure towards Salary for the months of December 2020 to March 2021.
- 6. The Government also directs the Director of Technical Education to fill up the post as per the Methodology suggested by him in the letter second read above, and to send the Utilization Certificate for the grants sanctioned at para 5 above to Government in due course.

7. The expenditure sanctioned in para 5 above shall be debited under the following Head of Account:-

- 8. The Director of Technical Education is the Estimating, Reconciling and Controlling Authority for the above new Head of Account. Pay and Accounts Officer / Treasury Officer concerned is directed to open the above new Head of Account in their books.
- 9. The expenditure sanctioned in para 5 above constitutes an item of "New Service". The approval of the Legislature will be obtained in due courses. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director of Technical Education is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of advance from the Contingency Fund will be issued from Finance (BG-I) Department. He is also requested to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimates 2020-21 to Finance (BG-I/Edn-I) Department at an appropriate time without fail.
- 10. This order issues with the concurrence of Finance Department vide it's C.No.105 DS(KU)/Edn-I/2020, dated 18.12.2020, U.O.No.49555/CMPC/2020, dated 22.12.2020 and ASL No.1172 (One thousand one hundred and seventy two).
