2. The Government, after careful consideration, approve the following resolutions passed in the 10<sup>th</sup> Equivalence Committee dated 28.10.2021 held under the Chairmanship of the Principal Secretary to Government, Higher Education Department and direct that the following Degree offered by Annamalai University be not equivalent to the course mentioned therein:-
