Sub: Higher Education – Revision of Pension to the retired Teachers of Government / Government Aided Colleges, governed by the UGC, prior to 01-01-2016 – Concordance Table – Reg.

I am directed to invite attention to the references cited.

- 2. In the reference first cited, the Government have approved the Ready Reckoner for calculation of Revision of pension / family pension with reference to the minimum of the revised pay scale +GP, based on the recommendations of the UGC VI Pay Revision, in respect of the teachers and equivalent cadres in Universities, Government / Government Aided Colleges, retired prior to 01-01-2006.
- 3. Based on the recommendation of the Official Committee, 2017 as constituted in G.O. (Ms) No:40 Finance (PC) Department dated: 22-02-2017, the Government in G.O (Ms) No:313, Finance (Pay Cell) Department, dated 25-10-2017, have issued orders, sanctioning revision of Pension / Family Pension and other retirement benefits along with Ready Reckoner, in respect of employees who have retired or died before 01-01-2016, with effect from 01-01-2016 and monetary benefit from 01-10-2017.

- 4. Based on the recommendation of the Pay Review Committee (PRC), constituted by the UGC, the Government in G.O. (Ms) No:145, Higher Education (H1) department dated:06-07-2018, Government have issued orders, for revision of pay scales & Allowances etc., to the teachers and equivalent cadres of State Universities and Government / Government Aided Colleges in Tamil Nadu, governed by the UGC, by giving notional effect from 01-01-2016 and with monetary benefit from 01-10-2017. In the above said G.O. with regard to Pension, Family pension it has been ordered as follows:-
 - (H) As regards, the revision of Pension, Family pension, Gratuity and encashment of Leave, Ex-gratia compensation and Provident Fund to the teachers and equivalent cadres governed by UGC shall be as applicable to the State Government Employees.
- 5. In the reference 5th cited, the Director of Collegiate Education has sent the concordance table (Ready Reckoner) for calculation of Pension / Family Pension for College teachers retired prior 2016 with monetary benefit from 01-10-2017, in the light of the orders issued in G.O. (Ms) No:313 Finance (PC) Department dated: 25-10-2017 and requested the Government to issue necessary orders in this regard, so as to facilitate the payment of revision pension / family pension for the retired College teachers with monetary benefit from 01-10-2017.
- 6. The Government after careful consideration approve the concordance table (Ready Reckoner) for calculation of revision of pension / family pension for the retired Teachers and equivalent cadres in Universities, Government / Government Aided Colleges, governed by the UGC, with reference to the minimum of the pay in the revised pay structure, with notional effect from 01-01-2016 and monetary effect from 01-10-2017, as in the annexure to this letter.
- 7. This letter issues with the concurrence of Finance Department vide its U.O. Note No: 67023/Fin(Pen)/2018, Dated. 24.01.2019.
