ORDER:-

Based on the norms fixed by the All India Council for Technical Education in their Notifications fifth and sixth read above, the Government in the Government Order seventh read above have issued orders revising among other things the qualifications prescribed for the post of Head of Department in the teaching posts in Polytechnic Colleges under the control of the Technical Education Department.

2. In the Government Order seventh read above, the nomenclature of the posts of Senior Lecturer, Workshop Superintendent and Superintendent Sandwich in Government Polytechnic Colleges have been changed as Lecturer. Hence the feeder category for the post of Head of Department is now Lecturer.

3. Accordingly, in the letter eighth read above, the Commissioner of Technical Education has sent necessary draft amendment proposals for revising the Adhoc Rules relating to the said post issued in the Government Order first read above. The Government after careful consideration have decided to accept the proposals of the Commissioner of Technical Education and issue the following amendments to the Adhoc Rules governing the post of Head of Department in Government Polytechnic Colleges under the control of the Technical Education Department.

4. The following Notification will be published in the Tamil Nadu

NOTIFICATION .

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the rules issued with the Education Department Notification S.R.O. No.A 117 of 1969, published at page 140 in Part V of the <u>Fort.St.George Gazette</u>, dated the 26th March 1969.

2. The amendments hereby made shall be deemed to have come into force on 25th May 2010.

AMENDMENTS

In the said Adhoc Rules, -

- (1) in rule 3,-
 - (a) in item (i), the expression, "Workshop Superintendents, Superintendents (Sandwich) and Superintendents (Government Technical Higher Secondary Schools)" shall be omitted;
 - (b) item (ii) shall be omitted;
- (2) in rule 5, -

(a) for items (I), (II) and (III) and the entries relating thereto, the following items and entries shall respectively be substituted, namely:-

- (i) A Bachelor's and Master's Degree in the appropriate branch of Engineering / Technology / Architecture with First Class or equivalent either at Bachelor's or Master's Degree Level; and
 - (ii) Experience for a period of not less than 10 years in the relevant field of teaching / research / industry, in a position not below the rank of a Lecturer in Engineering Subjects, Workshop Superintendent and Superintendent (Sandwich) in a Polytechnic or equivalent grades in other Institutions:

Provided that in the case of Architecture branch, professional practice of not less than 10 years as certified by the Council of Architecture shall also be considered valid.

A Bachelor's and Master's Degree in the appropriate branch of Engineering / Technology / Architecture with First Class or equivalent either at Bachelor's or Master's Degree Level ; and

- (ii) Ph.D or equivalent obtained from a recognised University in the appropriate discipline in Engineering / Technology / Architecture; and
- (iii) Experience for a period of not less than 5 years in the relevant field of teaching / research / industry, in a position not below the rank of a Lecturer in Engineering Subjects, Workshop Superintendent and Superintendent (Sandwich) in a Polytechnic or equivalent grades in other Institutions:

Provided that in the case of Architecture branch, professional practice of not less than 5 years as certified by the Council of Architecture shall also be considered as valid.

(b) after the last proviso, the following Explanations shall be added, namely:-

Explanations:-

- (i) Equivalence of Ph.D. shall be based on publication of 5 International Journal papers, each Journal having cumulative impact index of not less than 2.0, with incumbent as the main author and all the 5 publications being in the authors' area of specialization.
- (ii) Bachelor's degree in the branch of Engineering / B.Tech./ M.E./ M.Tech./ Ph.D. shall be from a recognized University.
- (iii) In case of research experience, good academic record and technical books / research paper publications / Intellectual Property Rights / patents record shall be required.
- (iv) If the experience in industry is considered, the same shall be at the managerial level equivalent to that of Head of Department with active participation record in designing, planning, executing, analyzing, quality control, innovation, training, technical books / research paper publications/ Intellectual Property Rights/ patents record.
- (v) Flair for Management and Leadership shall be considered as essential.

(vi) If a class / division is not awarded, minimum of 60% marks in aggregate shall be considered as equivalent to first class / division. If a Grade Point System is adopted, the Cumulative Grade Point Assessment shall be converted into equivalent marks as mentioned below:-

Grade Point	Equivalent Percentage
6.25	55%
6.75	60%
7.25	65%
7.75	70%
8.25	75%

(3) after rule 8, the following rule shall be added, namely :-

9. <u>Savings</u>:- "Nothing contained in these rules shall adversely affect the persons holding the post on the date of issue of these rules".
