### **ORDER:-**

In the letter second read above, the Member Secretary (FAC), Tamil Nadu State Council for Higher Education has furnished the resolution passed in the 5<sup>th</sup> Equivalence Committee (through circulation) dated 17.12.2020 under the Chairmanship of the Principal Secretary to Government, Higher Education Department, on the specialized course viz. M.Com. (Co-operative Management) awarded by Annamalai University to be not equivalent to the Junior Grade Accountancy examination conducted by Directorate of Technical Education and requested the Government to issue orders in the matter.

The Government, after careful consideration, approve the following resolution passed in the 5<sup>th</sup> Equivalence Committee (through circulation) dated 17.12.2020 under the Chairmanship of the Principal Secretary to Government, Higher Education Department and direct that the following Degree offered by the Annamalai University be not equivalent to the examination mentioned therein:-
