ORDER:-

In the letter second read above, the Chairperson, Equivalence Committee / Principal Secretary to Government, Higher Education Department has forwarded the resolutions passed by the 5th Equivalence Committee meeting held on 07.01.2021 and 12.01.2021 under the Chairmanship of the Principal Secretary to Government, Higher Education Department, on the equivalence of Degrees offered by Universities/ Educational Institutions to the similar Degrees for the purpose of employment in Public Services and requested the Government to issue orders in the matter.

2. The Government, after careful examination,

i) Approve the following resolutions passed in the 5th Equivalence Committee meeting held on 07.01.2021 and 12.01.2021 under the Chairmanship of Principal Secretary to Government, Higher Education Department and direct that the following degrees offered by Universities / Educational Institutions be equivalent to the similar degrees mentioned therein from the date of issuance of such degrees for the purpose of employment in Public Services and also direct that no person shall be eligible for appointment to any service, class , category or grade or any post borne on the cadre thereof, unless he/she possesses such special qualifications and has passed such special tests as may be prescribed in that behalf in the special rules; or possesses such other qualifications as have been declared to be higher than or equivalent to the said special qualifications or special tests, by the Government in consultation with the Committee constituted in the Government Order first read above and by the Government or by the appointing authority with the approval of the Government in other cases:-

ii) Validate and approve that B.Tech. degree / diplomas awarded by Indira Gandhi National Open University (IGNOU) to the students who were directly enrolled in IGNOU and course wise recognition provided to its approved institutions by IGNOU upto academic year 2009-10 be treated as equivalent to regular B.Tech. degree / Diplomas as a special case as per direction issued by All India Council for Technical Education (AICTE) / Ministry of Human Resource Development (MHRD) for the purpose of employment in Public Services.
