



ABSTRACT

Technical Education – Announcement made by Hon'ble Chief Minister during 2014-2015 - Establishment of 2 new Government Polytechnic Colleges at Kooduveli village in Cuddalore District and Sevvaipettai Village in Thiruvallur District – Administrative and Financial sanction for recurring & non-recurring expenditure and sanction of Teaching & Non-teaching Posts – Orders – Issued.

ORDER:-

During the Budget session 2014-2015, the following announcement related to Adi Dravidar and Tribal Welfare Department was made by the then Hon'ble Chief Minister on 31-07-2014 in the Tamil Nadu Legislative Assembly:-

2. In the Government order first read above, Administrative Sanction was accorded for Rs.111,46,66,000/- (Rupees One Hundred and Eleven Crore Forty Six Lakhs and Sixty Six Thousand only) including Recurring Expenditure in connection with staff Salary for I, II and III Year for Rs 3742.70 Lakhs and Non Recurring Expenditure in connection with purchase of Furniture, Equipment, Library Books & e-Journals and Computers for Rs 7403.96 Lakhs for the proposed two Government Polytechnic Colleges at Thiruvallur and Cuddalore Districts.

3. In the letter second read above, the Commissioner of Technical Education has sent a detailed proposal, containing the details of (i) requirement of land (ii) courses to be offered (iii) purchase of equipment, computers, furniture and library books & e-journals (iv) sanction of post (both teaching & non-teaching) for first academic year (v) recurring expenditure in connection with Staff Salary for first academic year (vi) cost estimate for construction of buildings (vii) Recurring expenditure in connection with contingencies, EB Charges, Postage, Remuneration, Stores and Stationery (viii) Temporary building for conduct of first year classes, for the establishment of 2 new Government Polytechnic Colleges at Kooduveli village in Cuddalore District and Sevvaipettai Village in Thiruvallur District. The Commissioner of Technical Education has also stated that AICTE Council Meeting held at New Delhi on 27.04.2017 and Letter of Approval was issued by AICTE for the above two Polytechnic Colleges for the year 2017-18. He has therefore requested the Government to accord

sanction of funds for the establishment of the two new Government Polytechnic Colleges at Kooduvelli Village in Cuddalore District and Sevvaipettai Village in Thiruvallur District as follows:-

- (i) Creation of 122 posts of Teaching, Technical, Administrative Staff & Basic Servants for the first academic year (61 posts per Polytechnic College).
- (ii) Rs 797.52 Lakhs towards recurring expenditure in connection with Staff Salary for the first academic year (Rs.398.76 lakh per Polytechnic College).
- (iii) Rs 4600.00 lakh towards Construction of Buildings except Hostels (Non Recurring) (Rs.2300.00 lakh per Polytechnic College).
- (iv) Rs. 100.00 Lakhs towards Purchase of equipment related (Non Recurring) (Rs.50.00 lakh per Polytechnic College).
- (v) Rs.41.00 Lakhs towards other contingencies, EB charges, Postage, Remuneration, Stores and Stationeries (Recurring) (Rs.20.50 lakh per Polytechnic College).

4. The Government after careful examination, accord administrative sanction for starting of two new Government Polytechnic Colleges at Kooduvelli Village in Cuddalore District and Sevvaipettai Village in Thiruvallur District with the five courses, viz., Civil Engineering, Mechanical Engineering, Electrical and Electronics Engineering, Electronics and Communication Engineering and Computer Engineering with sanctioned intake of 60 for each course with the medium of instruction as English, subject to the condition that admission should be made as per the Tamil Nadu Reservation Act 45 of 1994 [Tamil Nadu Backward Classes, Scheduled Caste and Scheduled Tribes (Reservation of seats in Educational Institutions and of appointment or posts in the Services under the State) Act, 1993] in the above two new Government Polytechnic Colleges from the academic year 2018-2019.

5. Accordingly, the Government

- (a) Sanction 74 posts [37 posts per Polytechnic College - 15 teaching, 10 non-teaching (Ministerial Staff), 7 Technical Posts and 5 basic servant posts] for first academic year (2018-2019), as detailed in the Annexure to this order, and the services of Sweeper, Sanitary Worker etc. shall be engaged on Outsourcing basis. Necessary provision for this has been made under the 'Contract Payment' Head of Account.
- (b) accord Administrative and Financial sanction for a sum of Rs.763.20 Lakhs (Rupees Seven crore Sixty three lakh and twenty thousand only) (Rs.381.60 Lakh per Polytechnic College) towards Recurring Expenditure in connection with staff Salary for first academic Year (2018-2019).
- (c) accord Administrative and Financial sanction for a sum of Rs.41.00 lakh (Rupees Forty one lakh only) (Rs.20.50 lakh per Polytechnic College) towards other Contingencies, EB Charges, Postage, Remuneration, Stores and Stationeries (Recurring).
- (d) accord Administrative and Financial sanction for a sum of Rs.4600.00 lakh (Rupees Forty six crore only) (Rs.2300.00 lakh per Polytechnic College) towards Construction of Buildings except Hostel (Non Recurring).

6. The Government also accord Administrative and Financial sanction for a sum of Rs.100.00 lakh (Rupees one crore only) (Rs.50.00 Lakh per Polytechnic College) as non-recurring expenditure for procurement of the following items required for the first academic year (2018-2019) :-
