ABSTRACT

UNIVERSITIES - Chennai, Annamalai, Madurai Kamaraj, Bharathiar, Bharathidasan, Alagappa, Mother Teresa, Manonmaniam Sundaranar, Periyar, Avinashilingam (Deemed University), Ambedkar Law and Thanjavur Tamil Universities - Revision of pay scales to the Deputy Registrar/Assistant Registrar on the basis of the recommendation of UGC - Orders - Issued.

ORDER:

Based on the recommendations of the University Grants Commission and followed by the decision of the Government of India, orders were issued in the Government Order read above extending the revised UGC Scales of pay to Teachers, Registrars, Controller of Examination and Vice-Chancellor in the Universities in Tamil Nadu. The revised scales of pay were extended with retrospective effect from 1.1.1996.


2. The UGC has also recommended the revised scales of pay for the following non-teaching posts in the Universities:

Name of the post	Existing scale	Revised scale recommended
Deputy Registrar	Rs.3700-175-4950-150-5700	Rs.12000-420-18300
Assistant Registrar	Rs.2200-75-2800-100-4000	Rs.8000-275-13500

The UGC has recommended adoption of the above revised scales of pay after satisfying the qualification and experience criteria prescribed for the above post.

3. The Government after careful consideration of the recommendations of the UGC have decided to implement the revised scales of pay for the post of Deputy Registrar and Assistant Registrar in the Universities in Tamil Nadu. Accordingly, the Government direct that the pay scales of Deputy Registrar and Assistant Registrar in the Universities of Chennai, Annamalai,

Madurai Kamaraj, Bharathiar, Bharathidasan, Alagappa, Mother Teresa, Manonmaniam Sundaranar, Periyar, Avinsahilingam (Deemed University), Ambedkar Law University and Tamil University Thanjavur shall be revised as below:

1. Deputy Registrar and equivalent post	3700-125-4950-150- 5700	12000-420-18300
2. Assistant Registrar and equivalent post	2200-75-2800-100- 4000	8000-275-13500

3.1. DATE OF EFFECT: The Revised scale of pay will be effective from 1.1.1996.

3.2. CONDITIONS FOR EXTENDING THE REVISED SCALES OF PAY:

- (i) The Government direct that the educational qualification prescribed by the UGC in respect of Deputy Registrar and Assistant Registrar should be followed before extending the above revised scales of pay.
- (ii) Wherever the existing pay scales of Deputy Registrar and Assistant Registrar are lower than the above revised scales of pay, the existing incumbents of these posts shall be allowed to move on to the above revised pay scales as and when they fulfil the educational and service qualifications prescribed by the UGC.
- (iii) Wherever the qualification of the present incumbents are not in conformity with the qualification prescribed by the UGC, they shall remain in the existing scale of pay.
- (iv) Similarly, wherever the existing scales of pay of the post of Deputy Registrar and Assistant Registrar are higher than the above revised pay scales recommended by the UGC, the existing incumbents shall be allowed to continue in the existing scale of pay. But future appointments to such posts of Deputy Registrar and Assistant Registrar should be allowed the above revised pay scales in accordance with the UGC guidelines.

(v) The Government also direct that if any University deviates from the above guidelines, the entire expenditure relating to such posts (not the difference in expenditure) will not be reimbursed to the University. This expenditure will not also be taken into account for the purpose of fixing block grant in future.

4. DEARNESS ALLOWANCE AND OTHER ALLOWANCES:

The Deputy Registrars and Assistant Registrars are entitled to receive revised Dearness Allowance in the revised scales of pay at the rate admissible to the State Government employees from time to time. They are also entitled to receive the revised rates of House Rent Allowance and City Compensatory Allowance with effect from 01.04.1998.

5. PAYMENT OF ARREARS:

Arrears will be paid from 1.1.1996. Out of the arrears due from 1.1.96 to 31.3.1999, 40% of arrears will be paid in cash and the balance 60% will be credited to the Provident Fund Account of the individual. The payment of arrears will be made soon after the State Government receives the 80% grant from the Central Government. Regarding the payment of arrears orders to be issued for the University teachers shall be applicable to the holders of these posts also.

6. RECRUITMENT AND QUALIFICATION:

Recruitment procedure to the post of Deputy Registrars and Assistant Registrars shall be on the basis of the statutes of the University subject to the fulfilling the guidelines of the UGC in this regard. The details of Educational and other qualifications for appointment as Deputy Registrars and Assistant Registrars are appended in the Annexure to this order. The Educational qualification prescribed by the UGC in respect of Assistant Registrars and Deputy Registrars shall be insisted, particularly in all future appointments to these posts.

7. AGE OF SUPERANNUATION:

The present age of 58 years will continue as the age of superannuation.

8. Anomalies, if any, in the implementation of the scheme shall be brought to the notice of the Government for clarification.

ANEXURE

Minimum qualifications for the direct recruitment to
the posts of DEPUTY REGISTRAR and ASSISTANT REGISTRAR.

(i) Deputy Registrar and equivalent posts:

1. A Master's degree with at least 55% of the marks or its equivalent grade of 'B' in the UGC seven point scale.
2. Five years' of experience as a Lecturer in a College or a University with experience in educational administration.

or

Comparable experience in research establishment and/or other institutions of higher education.

or

Five years' of administrative experience as Assistant Registrar or in an equivalent post.

(ii) Assistant Registrar and equivalent Posts:

1. Good academic record plus Master's degree with at least 55% of the marks or its equivalent grade of 'B' in the UGC seven point scale.
