ORDER:

The Commissioner of Technical Education has requested the Government to designate the Director of Technical Education as “appropriate authority” for admission to every Government seat in Engineering institutions, in order to improve the co ordination between Tamil Nadu Engineering Admissions Facilitation Centers (TFC’s) at District level and Nodal agency. The Government after careful consideration, accept the proposal of the Commissioner of Technical Education.

2. The following Notification will be published in the Tamil Nadu Government Gazette Extra-ordinary dated 4.4.2019.

NOTIFICATION

In exercise of the powers conferred by sub-section (1) of section 10 of the Tamil Nadu Admission in Professional Educational Institutions Act, 2006 (Tamil Nadu Act 3 of 2007), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Admission in Engineering Institutions Rules, 2007, namely:-

AMENDMENTS

In the said Rules.-

- (1) in rule 3, for the expression " Anna University, Chennai", the expression "Commissioner / Director of Technical Education, Chennai" shall be substituted;
- (2) after rule 7, the following rule shall be added, namely:-

"8. Powers of Authority.- The Commissioner/Director of Technical Education may utilize the services of any State University including Anna University and Annamalai University and the Tamil Nadu State Council for Technical Education (TANSCTE) for conducting Tamil Nadu Engineering Admissions (TNEA)".


