



ABSTRACT

Technical Education – Revised norms to be adopted for Admission to Second Year B.E/B.Tech. Degree Courses through Lateral Entry in the Colleges affiliated to Anna University from the year 2019-20 – 10% of approved intake - Orders – Issued.

ORDER:

In the Government Order first read above, the norms to be adopted for admission to second year B.E./ B.Tech degree courses through Lateral Entry from the academic year 2015-16 onwards have been issued. As per the norms, the students belonging to B.Sc stream shall be considered only after filling the supernumerary seats (20%) in Lateral entry category with students belonging to the Diploma stream.

2. The Commissioner of Technical Education in the letter second read above, has stated that in the AICTE Hand Book 2019-20, under the title Admission to Lateral Entry to second year courses, AICTE has specified as follows:

“6.9.(b.) Lateral Entry to Second Year Degree course(s) in Engineering and Technology Programme shall be permissible up to a maximum of 10% of the ‘Approved Intake’ which shall be over and above, supernumerary to the ‘Approved Intake’, plus the unfilled vacancies of the First Year”.

The Commissioner of Technical Education has therefore, requested to issue orders that,

“Admission to Lateral Entry to Second Year Degree Courses(s) in Engineering and Technology Programme shall be permissible up to a maximum of 10% of the ‘Approved Intake’ which shall be over and above, supernumerary to the ‘Approved Intake’, plus the unfilled vacancies of the First Year from the year 2019-20 in all the Engineering Colleges in Tamil Nadu on par with the norms of All India Council for Technical Education”.

3. The Government after careful examination, decided to accept the request of Commissioner of Technical Education in para 2 above and accordingly direct that Admission to Lateral Entry to Second Year Degree Courses(s) in Engineering and Technology Programme shall be permissible up to a maximum of 10% of the 'Approved Intake' which shall be over and above, supernumerary to the 'Approved Intake', plus the unfilled vacancies of the First Year from the year 2019-20 in all the Engineering Colleges in Tamil Nadu on par with the norms of All India Council for Technical Education.
