ORDER:

In the Government Order first read above, the Government have issued orders of Adhoc Rules for the post of Head of Department in Commerce in the Government Polytechnics.

- 2. In the Government Order third read above, the Government have issued orders regarding the implementation of certain guidelines and recommendations of All India Council for Technical Education (AICTE), wherein qualifications for the post of Head of Department in Diploma level institutions has been prescribed.
- 3. In the AICTE Notification dated 04.01.2016, the AICTE has issued Clarifications on certain issues / anomalies pertaining to qualifications, pay scales, service conditions, Career Advancement Schemes (CAS) etc, for teachers and other academic staff of Technical Institutions (Degree/Diploma). In the above said Notification, the AICTE has prescribed qualification and experience for the faculty of Commerce in Polytechnic Colleges.
- 4. Based on the AICTE Notification dated 04.01.2016, in the Government Order fifth read above, orders were issued for implementing the same. Based on the above, in the letter sixth read above, the Director of Technical Education has sent necessary proposal for the amendments to Adhoc rule for the post of Head of Department in Commerce in the Government Polytechnics including Government Polytechnics for Women and Special Institutions. The Government after careful consideration have decided to accept the proposal of the Director of Technical Education and issue the following amendments.

The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the rules published with the Education Department, Notification No. SRO.B-193/87, dated the 25th May 1987 at pages 257-258 of Part III Section-I (b) of the <u>Tamil Nadu Government Gazette</u>, dated the 24th June 1987.

2) The amendments hereby made shall be deemed to have come into force on the date of issue of order.

AMENDMENTS.

In the said Adhoc Rules,

- (1) in rule 4, -
 - (i) in sub-rule (a) for the expression "thirty six years" the expression "fifty seven years" shall be substituted;
 - (ii) for sub-rule (b), the following sub-rule shall be substituted, namely:-
 - (b) Other qualifications:- No person shall be eligible for appointment to the post by the method specified in column (2) unless he possesses the qualifications specified in column (3) thereof.
