## ORDER:

The Hon'ble Minister for Medical and Family Welfare has made the following Budget Announcement on the floor of assembly during Budget session 2021-2022:-

"Joint Director of Health Services post will be created to the newly formed Chengalpattu, Tenkasi, Kallakurichi, Ranipet, Tirupattur and Mayiladuthurai Districts at a cost of Rs.1.11 crore".

- 2. Based on the above announcement, the Director of Medical and Rural Health Services, in his letters read above, has submitted the proposal for the formation of a separate Office of the Joint Director of Health Services, in the Ranipet, Tirunelveli, Tiruppathur, Chengalpattu, Kallakurichi and Mayiladuthurai Districts, with the sanction of the posts of Joint Director of Health Services.
- 3. The Director of Medical and Rural Health Services has stated that in G.O.Ms.No.431, Revenue and Disaster Management Department, (Revenue Administration Wing (RA1(1)) section), dated 12.11.2019, orders were issued for forming the following new districts by bifurcating from the erstwhile Districts, in order to ease the administration of the larger District:-

1. Vellore

- Trifurcated into Vellore, Ranipet and Tiruppathur Districts.
- Tirunelveli
- Bifurcated into Tirunelveli and Tenkasi Districts.

3. Villupuram - B

Bifurcated into Villupuram and Kallakurichi Districts

4. Kancheepuram

 Bifurcated into Kancheepuram and Chengalpattu Districts.

5. Nagapattinam

Bifurcated into Nagapattinam and Mayiladuthurai Districts.

After the bifurcation and trifurcation from the formerly combined districts, Tenkasi, a newly created district has the Office of the Joint Director of Health Services leaving the Tirunelveli district and five other newly created districts mentioned below, without the Office of the Joint Director of Health Services, which is important to administrate the entire districts health administration.

(1) Ranipet (2) Tirunelveli (3) Tiruppathur (4) Chengalpattu (5) Kallakurichi and (6) Mayiladuthurai

The details of Taluk, Non-Taluk and Government Hospitals, consist in the above said districts are as follows:

1. Ranipet

 Wallaja, Arakonam, Arcot, Sholinghur, Kalavi and Punnai in Nemili taluk.

2. Tirunelveli

 Ambasamudram, Cheranmadevi, Kalakad, Mannur, Nanguneri, Palayamkottai, Pappakudi, Radhapuram and Valliyoor.

3. Tiruppathur

Tiruppathur, Vaniyambadi, Ambur and Natrampalli.

4. Chengalpattu

Thirukkazhikundram, Chengalpattu, Madurantakam, Cheyyur, Tiruporur, Tambaram, Pallavaram and Vandalur.

5. Kallakurichi

 Kallakurichi, Sankarapuram, Chinna Salem, Ulundurpet, Thirukovilur and Kalvarayanmalai.

6. Mayiladuthurai

Mayiladuthurai,Tharangambadi, Kuttalam, Vaitheeswarankoil and Sirkali.

4. The Director of Medical and Rural Health Services has further stated that Ranipet, Tirunelveli, Tiruppathur, Chengalpattu, Kallakurichi and Mayiladuthurai Districts are functioning as separate Revenue Districts. It is necessary to create a separate Officer of the Joint Director of Health Services in the District itself to look after all the health related administration and to attend the meetings and review meetings conducted by the District Collectors of the newly formed Districts as well as

to attend the meetings as a representative of their districts conducted by the State Health Officials regarding the various districts health programmes.

- 5. The Director of Medical and Rural Health Services has, therefore, requested the Government to accord sanction for the formation of a 'separate Joint Director of Health Services Office for the Ranipet, Tirunelveli, Tirupathur, Chengalpattu, Kallakurichi and Mayiladuthurai Districts, with the sanction of the 'posts of Joint Director of Health Services' with a recurring expenditure of Rs.1.11 Crore per annum.
- 6. The Government after careful examination of the proposal of the Director of Medical and Rural Health Services in detail, accord sanction for the formation of a 'separate Joint Director of Health Services Office for the Ranipet, Tirunelveli, Tirupathur, Chengalpattu, Kallakurichi and Mayiladuthurai Districts, with the sanction of 'six posts of Joint Director of Health Services' (each one for each district) at a recurring expenditure cost of Rs.1.11 Crore per annum (Rupees One Crore and eleven lakh only) and accord financial sanction for sum of Rs.27,90,486/- in the current financial year 2021-22 in the minimum pay of Rs.1,23,100 (level 28).
- 7. The expenditure sanctioned in para 6 above shall be debited under the following Head of Account:-

"2210 Medical and Public Health – 01 Urban Health Services – Allopathy – 001 Direction and Administration – State's Expenditure - AB District Medical Officers of Non-Teaching Institutions, Headquarters Hospitals"

301 – Salaries – 01 Pay – Rs.22,15,800 (DPC 2210 01 001 AB 30101)

301 – Salaries – 02 Medical Allowance – Rs.5,400 (DPC 2210 01 001 AB 30102)

301 - Salaries - 04 Other Allowance - Rs.1,35,000 (DPC 2210 01 001 AB 30104)

301 - Salaries - 06 House Rent Allowance - Rs.57,600 (DPC 2210 01 001 AB 30106)

303 - Dearness Allowance - 01 Dearness Allowance - Rs.3,76,686 (DPC 2210 01 001 AB 30301)

8. Necessary additional funds of Rs.27,90,486/- will be provided in Revised Estimate/Final Modified Appropriation 2021-2022. However, this expenditure shall be brought to the notice of the Legislature by **Specific Inclusion** in the Supplementary Estimate 2021-2022. Pending provision of such funds, the Director of Medical and Rural Health Services is authorized to draw and disburse the amount sanctioned in the para 6 above. The Director of Medical and Rural Health Services is directed to include this item of expenditure while sending the budget proposal for Revised Estimate/Final Modified Appropriation 2021-2022 and also

send necessary draft explanatory note for inclusion of this expenditure in the Supplementary Estimate 2021-2022 to Government in Finance (Health-II/BG-1) Department at the appropriate time without fail.
