## ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following Announcement in the floor of the Tamil Nadu Legislative Assembly:-

### Announcement No:22

"சேலம் அரசு மருத்துவக் கல்லூரி மருத்துவமனைக்கு செவிலியர் பயிற்சிப்பள்ளி கட்டடம் ரூபாய் 35.15 கோடி மதிப்பீட்டில் அமைக்கப்படும்".

2. The Project Director, Tamil Nadu Health System Reform Program in the letter read above, has detailed the present status of the school of nursing in Government Mohan Kumaramangalam Medical College Hospital, Salem that which is established in 1980 and 273 students studying at present, out of 300 seats were sanctioned. Hence, it is justified to take up the activity to build a new academic and hostel building by demolishing the existing old and dilapidated academic building and Staff Nurse Hostel / Quarters and the non-recurring cost involved in the above said activity is worked out to Rs.35,14,50,000/-.

3. The Project Director, Tamil Nadu Health System Reform Program has stated that the State Empowered Committee has approved the above proposal and out of the estimated value of Rs.31,08,41,255/- for the above proposed work Rs.10.00 Crore is required in the current financial year 2023-2024 and the balance funds of Rs.21.08 Crore may be provided in the next financial year 2024-2025 and requested the orders of the Government.

4. The Government, after careful examination, have decided to accept the proposal of the Project Director, Tamil Nadu Health System Reform Program by restricting the proposed amount as follows and accord an administrative sanction for a sum of Rs.31,08,41,255/- (Rupees Thirty one crore eight lakh forty one thousand



two hundred and fifty five only) and financial sanction for a sum of Rs.10,00,00,000/- (Rupees Ten crore only) towards construction of academic and hostel building for school of nursing in Government Mohan Kumaramangalam Medical College Hospital, Salem through Public Works Department and order accordingly:-

6. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-

“4210 – Capital Outlay on Medical and Public Health – 01 Urban Health Services - 200 other Health Schemes – External Aided Project – PC – Tamil Nadu Health System Reforms Project – Administrated by the Director of Medical Education – 416 Major works – 01 Major works.”

7. Necessary funds of Rs.10,00,00,000/- will be provided in Revised Estimate/ Final Modified Appropriation 2023-2024. Pending provision of such funds, the Director of Medical Education and Research is authorized to draw and disburse the above sanctioned amount. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2023-2024. The Director of Medical Education and Research is also requested to include this expenditure while sending the budget proposals for Revised Estimate / Final Modified Appropriation 2023-2024 and also send draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2023-2024 to Government in Finance (BG-I/Health-II) Department at an appropriate time without fail.
