#### ORDER:

In the Government Order first read above, the annual maintenance grant sanctioned to the Voluntary Health Services, Adyar was enhanced from Rs.21,11,700/- to Rs.50,18,750/- with effect from 01.04.2006 subject to usual conditions governing the payment of maintenance grant to Private Medical Institutions. In the Government Order second read above, an amendment has been issued to the Government order first read above incorporating the following:-

"The Government also direct the release of advance maintenance grant of Rs.12,00,000/- each in April/August/December every year and the balance of Rs.14,18,750/- or actual deficit whichever is less in the succeeding year after receipt of Local Fund Audit Departments audited statement of Accounts"

- 2. In the Government Order third read above, orders were issued enhancing the annual maintenance grant of the Voluntary Health Services, Adyar as from Rs.50,18,750/- (Rupees fifty lakhs eighteen thousand seven hundred and fifty only) to Rs.76,38,538/- (Rupees seventy six lakhs thirty eight thousand five hundred and thirty eight only) for a period of three years (viz. 1.4.2012 to 31.3.2015), subject to the usual conditions governing the payment of maintenance grant to Private Medical Institutions and accordingly sanctioned a sum of Rs.78,59,364/- (Rupees Seventy eight lakhs fifty nine thousand three hundred and sixty four only) for the above purpose.
- 3. In the letters fourth read above, based on the request of the Honorary Secretary, Voluntary Health Services, Adyar, the Director of Medical and Rural Health Services has requested the Government to clarify the enhancement of annual maintenance grant of Voluntary Health Services, Adyar.



- 4. The Government, after careful examination of the proposal of the Director of Medical and Rural Health Services, enhance the annual maintenance grant to the Voluntary Health Services, Adyar as from Rs.50,18,750/- (Rupees fifty lakhs eighteen thousand seven hundred and fifty only) to Rs.76,38,538/- (Rupees seventy six lakhs thirty eight thousand five hundred and thirty eight only) from the financial year 2015-2016, subject to the usual conditions governing the payment of maintenance grant given to Private Medical Institutions and accordingly sanction a sum of Rs.78,59,364/- (Rupees Seventy eight lakhs fifty nine thousand three hundred and sixty four only) for the above purpose.
- 5. The Government also direct the release of advance maintenance grant of Rs.22,91,561/- each in April / August and Rs.15,27,708/- in December every year and the balance Rs.15,27,708/- or actual deficit whichever is less in the succeeding year after receipt of local Fund Audit Department's audited statement of Accounts.
- 6. The expenditure sanctioned in para 4 above shall be debited to the following head of Account:

"2210 – Medical and Public Health – 80 General - 800 Other expenditure – State's Expenditure AB Grants to Private Medical Institutions – Controlled by Director of Medical and Rural Health Services –309 Grants-in-Aid-01 Grants for current expenditure" (DPC-2210-80-800-AB-30901)

- 7. Necessary additional funds has been provided in the Revised Estimate 2020-2021.
- 8. This order issues with the concurrence of the Finance Department vide its U.O. No.31638/Health-II/2020, dated 01.10.2020.
