The Director of Medical Education in his letter read above, has sent proposal along with rough cost estimate prepared by the Engineer-in-Chief (Buildings) and Chief Engineer (Buildings), Chennai Region, Public Works Department, Chennai for the construction of Additional Cooler room, Cadaver tank room, Embalming room and water supply arrangements for Madras Medical College at old Jail Campus, Chennai at an estimated cost of Rs.59.00 lakh for the year 2016-2017 and Rs.64.90 lakh for the year 2017-2018, by adding 10% escalation cost, duly countersigned by him and requested the Government to issue necessary administrative and financial sanction for a sum of Rs.59.00 lakh for the year 2016-2017 and Rs.64.90 lakh for the year 2017-2018 for the above construction.

The Government have examined the proposal of the Director of Medical Education in detail and accord administrative and financial sanction for a sum of Rs.67.14 lakh (Rupees Sixty seven lakh fourteen thousand only) for construction of Additional Cooler room, Cadaver tank room, Embalming room and water supply arrangements for Madras Medical College at Old Jail Campus, Chennai.
