ORDER:

The Mission Director, National Health Mission in his letter read above, has stated that the Ophthalmic Blocks in 25 Government Hospitals were constructed four decades ago under World Bank Aided Programmes. The buildings are now in decrepit condition and attract much expenditure towards the repair and renovation works. Besides, the repairs and modernizing, the operation theatre also compromise the sterility. Therefore, it has been proposed to strengthen them in phased manner with the provision of Ophthalmic Operation Theatres with Post Operative Wards to deliver standard Eye Care Services.

2. The Mission Director, National Health Mission has also stated that in order to strengthen the Government Hospitals, a detailed proposal has been included in Programme Implementation Plan 2019-20, for constructing Eye Operation Theatre with Post Operative wards in the following 5 Hospitals, at a total cost of Rs.60 lakh each, under National Blindness Control Programme and Visual Impairment:-

- (i) District Head Quarters Hospital Tiruppur, Tiruppur District.
- (ii) Sub District Hospital Tindivanam, Viltupuram District.
- (iii) Sub District Hospital Thiruchendur, Thoothukudi District.
- (iv) District Head Quarters Hospital Cuddalore, Cuddalore District.
- (v) District Head Quarters Hospital Palani, Dindigul District

3. The Mission Director, National Health Mission has further stated that the proposal has been approved by the NPCC of Government of India (Record of Proceedings 2019-20) as detailed below:-

The proposal has been approved in the 37th Executive Committee Meeting held on 11.02.2019.

4. As per the directions issued in G.O (Ms) No 116, Health and Family Welfare (EAP-II-2) Department, dated: 25.03.2011, the fund approved for civil works under National Health Mission, has to be remitted into Government of Tamil Nadu account, under Receipt Head of Accounts and the funds are to be sanctioned for execution of civil works through Public Works Department.

5. The Mission Director, State Health Society has therefore requested necessary orders in this regard.

6. The Government after careful examination of the proposal of the Mission Director, National Health Mission have decided to accept the same and accordingly issue the following orders:-

- i. The Mission Director, National Health Mission – Tamil Nadu is permitted to construct Eye Operation Theatre with Post Operative ward in the following 5 Hospitals at a total cost of Rs.300 lakh, at the rate of Rs.60 lakh per Hospital:-

5	District Head Quarters Hospital Palani, Dindigul District

- ii. Administrative Sanction is accorded to execute the above said Civil Works at a total cost of Rs.300 Lakh through Public Works Department. The Financial sanction will be given only after receipt of the amount in to the State Government Account.
- iii. The Mission Director, National Health Mission is directed to remit the Government of India fund as and when received under National Rural Health Mission for Civil Works.
- iv. The above work will be executed through Public Works Department.
