ORDER:

The Government of Tamil Nadu has established Bio Medical Waste Management System in all 270 Secondary Care Government hospitals, 41 Medical College hospitals and hospitals attached to Medical Colleges and 130 upgraded Primary Health Centres in the year 2008. All Health Care Providers in these institutions have been trained in the principles and practice of Bio Medical Waste Management namely segregation of the waste at the source of generation , transportation to the Bio Medical Waste Storage room , collection of waste by the Common Treatment Facility (CTF) operator and end disposal at the Common Treatment Facility. The Government had permitted contracting of 9 private Common Treatment Facility operators to collect the waste at the facility level, transport and dispose them of at their Common Treatment Facility. The contract was facilitated by the Tamil Nadu Medical Service Corporation. Since then the system is in place and is working well. However the Health Care Providers and other workers in the hospitals and PHCs need to be trained and re-trained regularly in respect of new entrants and for existing workers respectively. As there is a shortage of free lance trainers for Bio Medical Waste Management, the Government as per the Government Order referred above had permitted Tamil Nadu Health Systems Project (TNHSP) to establish Regional Training Centres on Bio Medical Waste Management in 7 Government Medical Colleges and Two Private Medical Colleges .

2. In the reference cited, the Project Director, Tamil Nadu Health Systems Project has reported that so far 41,868 health care providers have been given training on the implementation of Bio Medical Waste Management and that about 25,000 persons are yet to be trained and that now it has been proposed to impart training on Infection Control practices also. For this purpose, the Project Director, Tamil Nadu Health Systems Project placed a proposal before the State Empowered Committee in the meeting held on 01.08.2014 for sanction of Rs. 1,18,12,500 (Rupees one crore eighteen lakh twelve thousand and five hundred only) for imparting of training to the health care providers on the practices of Infection Control and Bio Medical Waste Management in Government Hospitals. The State Empowered Committee had approved the proposal, and accordingly, the Project Director has requested the Government to issue orders in the matter.

3. This activity has been approved by the World Bank and comes under Component III and Sub-component C and the expenditure is eligible for reimbursement from the World Bank.

4. The Government after careful consideration accord sanction for incurring an expenditure of Rs. 1,18,12,500 (Rupees One crore eighteen lakh twelve thousand and five hundred only) for imparting of training to the health care providers on the practices of Infection Control and Bio Medical Waste Management in Government Hospitals, as detailed below:

5. The break up details for the course fee are indicated in the Annexure to this order.

6. The Project Director Tamil Nadu Health Systems Project is permitted to print the above training modules by following World Bank Procurement Procedures and distribute the printed manuals to the Regional Training Centres as per their need. The Project Director is also permitted to incur any excess expenditure in printing up to 20 percent of the proposed cost per manual without coming to the State Empowered Committee for ratification.

7. The Project Director, Tamil Nadu Health Systems Project is permitted to transfer the training course fees to the Regional Training Centres periodically as per their demand based on the number of estimated trainees. While sending the training course fees, the cost of training manuals shall be deducted.

8. The Project Director, Tamil Nadu Health Systems Project is also permitted to reallocate the non recurring expenditure without exceeding the total cost sanctioned.

9. The expenditure sanctioned in para 4 above shall be debited to the following head of account:
