ORDER:-

In the Government Order first read above, orders have been issued sanctioning a sum of Rs.1.50 Crore at the rate of Rs.30.00 Lakhs per District towards Strengthening of Clinical Laboratories for 5 Government District Headquarters Hospitals located in Pudukottai, Namakkal, Tiruppur, Virudhunagar and Ramanathapuram for the period from October 2014 to September 2015.

- 2. The Director of Medical and Rural Health Services has stated that a sum of Rs.1.40 Crore is approximately required to settle the bills for the further period from October 2015 to March 2016 of this financial year. He has requested the Government to accord sanction for the balance amount of Rs.75,00,000/- (Rupees Seventy Five Lakhs only) for the year 2015-2016 and the remaining amount i.e. Rs.65.00 Lakhs (out of Rs.1.40 Crore) shall be met from other sources i.e. Chief Minister's Comprehensive Health Insurance Scheme funds etc., towards strengthening of Clinical Laboratories for 5 Government District Headquarters Hospitals in Pudukottai, Namakkal, Tiruppur, Virudhunagar and Ramanathapuram for the period from October 2015 to March 2016.
- 3. The Government have examined the proposal of Director of Medical and Rural Health Services in detail and accord sanction a sum of Rs.75,00,000/-(Rupees Seventy Five Lakhs only) towards strengthening of Clinical Laboratories for 5 Government District Headquarters Hospitals in Pudukottai, Namakkal, Tiruppur,

Virudhunagar and Ramanathapuram for the period from October 2015 to March 2016 and for remaining amount of Rs 65.00 Lakhs, the Director of Medical and Rural Health Services is directed to follow the orders issued in the Government Order first read above.

4. The expenditure sanctioned at para 3 above shall be debited in the following Head of Account;

2210 Medical and Public Health - 01 Urban Health Services - Allopathy - 001 Direction and Administration - AJ Payment to contract Agencies for outsourcing - 33-Payments for Professional and Special Services 09 – Other Payments.
