ORDER:-

In the Government Order first cited orders were issued according Administrative and Financial sanction for a sum of Rs.27.95 crore for construction of building for Centre of Excellence for Rehabilitation Medicine and Artificial Limb Centre, K.K.Nagar, Chennai.

2. In his letter second read above, the Director of Medical Education has stated that Government have accorded administrative and financial sanction for a sum of Rs.27,95,00,000/- for the work of construction of Centre of Excellence in the Government Institute of Rehabilitation Medicine and Artificial Limb Centre, K.K.Nagar, Chennai. The above said expenditure has been ordered to be debited under the Head of Account 4210-01-200-PC-41601. Out of the total administrative sanction an expenditure of Rs.25,73,87,000/- was incurred upto 31.03.2022. During the year 2021-2022, a sum of Rs.12,94,99/- (Twelve crore ninety four lakh and ninety nine thousand only) was obtained in the RE 2021-2022 for the above said work, but only a sum of Rs.10,76,85/- (Ten crore seventy six lakh and eighty five thousand only) were incurred upto 31.03.2022 and the balance amount was surrendered in FMA-II vide the Engineer-in-Chief (Buildings), Chennai Region, Public Works Department, Chepauk, Chennai letter No.B1/70200/2022 FMA-II 2021-2022, dated 31.03.2022. The Director of Medical Education has stated that a sum of Rs.2,21,13,000/- (Two crore twenty one lakh and thirteen thousand only) has to be incurred during the Financial year 2022-2023.

3. The Director of Medical Education has further stated that the Engineer in Chief (Buildings), Chennai Region, Public Works Department, Chepauk, Chennai has informed that the Government have provided only a token provision in the Budget Estimate for the year 2022-2023 under the head of account 4210-01-200-PC-41601. Hence the Director of Medical Education has requested to sanction the surrendered amount of Rs.2.21 crore in the RE/FMA 2021-2023 to carry out the above construction work.

4. The Government after careful examination of the proposal of the Director of Medical Education in detail and accord additional sanction for a sum of Rs.2,21,13,000/- (Rupees Two crore twenty one lakh and thirteen thousand only) for construction of Centre of Excellence for Rehabilitation in the Government Institute of Rehabilitation Medicine and Artificial Limb Centre, K.K.Nagar, Chennai.

5. The amount sanctioned in para 4 above shall be debited to the following head of account:-

"4210-Capital Outlay on Medical and Public Health – 01 Urban Health Services-200-Other Health Schemes Externally Aided Projects-PC-Tamil Nadu Health Systems Reforms Project-416-Major Works 01 – Major Works"
(DPC:- 4210-01-200-PC-41601)

6. Necessary additional funds of Rs.2,21,13,000/- will be provided in FMA 2022-2023. Pending provision of such funds the Director of Medical Education is authorized to draw and disburse the amount sanctioned at para 4 above. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2022-2023. The Director of Medical Education is also requested to include this expenditure while sending the budget proposals for FMA 2022-2023 and also send draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2022-2023 to Government in Finance (BG-I/Health-II) Department at the appropriate time, without fail.

7. This order issues with the concurrence of Finance Department, vide its U.O.No.9063/Health-II/2023, dated 25.06.2023 and ASL No.2736 [Two thousand seven hundred and thirty six] (IFHRMS ASL No.2023032736).


