ORDER:

In the circumstances reported by the Director of Medical Education in her letters third and fourth read above, the Government accord sanction for revival of two temporary posts of Lift Attendant attached to Government Arignar Anna Memorial Cancer Hospital, Kancheepuram which were originally created in the Government order first read above and last continued upto 30.09.1993 in the Government Order second read above from the date of filling up of the posts i.e., from 02.08.2008 and 04.08.2008.

2. Sanction is accorded further continuance of the above said two temporary posts for the period from the date of filling up of the post i.e., from 02.08.2008 and 04.08.2008 upto 30.09.2015 or till the need therefor ceases whichever is earlier.

3. The holders of the posts are eligible to draw besides pay in the time scale of pay Rs.4800-10000 Grade pay of Rs.1400 Dearness Allowance, House Rent Allowance and other allowances admissible under the rules in force and subsequent orders issued from time to time.

4. The Expenditure shall be debited to the following Head of Account:-
