ORDER:

In the letter read above, the Mission Director, State Health Society has stated that the Government of India have transferred and credited into State Government Account its share towards Grants-in-Aid for Flexible Pool for Communicable Diseases under National Health Mission during 2017-18 as detailed below:-

2. The corresponding 40% of the State Share against the 60% of the Government of India release of Rs.4,95,00,000/- (Rupees Four crore and ninety five lakh only) works out Rs.3,30,00,000/- (Rupees Three crore and thirty lakh only).

3. The Mission Director, National Health Mission has requested the Government to issue orders for the release of a sum of Rs.8,25,00,000 /- (Rupees Eight crore and twenty five lakh only) towards the Central and State share (SCSP and STSP) contribution of Grants-in-Aid Flexible Pool for Communicable Diseases

during 2017-18(SCSP and STSP) as mentioned above and to authorize him to draw the same amount under National Health Mission through Treasury mode.

4. The Government after careful consideration have decided to accept the above proposal of the Mission Director, State Health Society and accordingly sanction a sum of Rs.8,25,00,000 /- (Rupees Eight crore and twenty five lakh only) being the Central and State share contribution of Grants-in-Aid for Flexible Pool Communicable Disease during 2017-18 under National Health Mission to the State Health society.
