ORDER:

In Government Order first read above, Government have prescribed certain fee structure for self-financing private institutions for availing clinical training / Data Collection / Observer ship / Research Work / Project etc. in Government Medical Institutions.

2. In Government Order second and third read above, revised guidelines were issued for starting of Bachelor of Physiotherapy (BPT) and Bachelor of Occupational Therapy (BOT) courses respectively in the Government and Self-Financing / Private Institutions.

3. The Director of Medical Education in his letter fourth read above has requested the Government to fix the fees for scrutiny of the proposals sent by the Self-Financing Private Institutions requesting permission to start Paramedical Allied

Health Science Courses. The Director of Medical Education has proposed the following fees structure:

- a) Proposals for starting the Paramedical Allied Health Science Degree Courses - Rs. 1,00,000/- per proposal
- b) Proposals for starting the Post Graduate Paramedical Allied Health Science Courses - Rs. 2,00,000/- per proposal

4. The Government after careful examination, decided to accept the proposal of the Director of Medical Education and accordingly order the collection of fee for scrutiny of the proposals submitted by the Self Financing Private Institutions to start Paramedical Allied Health Science Courses as detailed below:-

- i. Paramedical Allied Health Science Degree Courses - Rs. 1,00,000/- (Rupees one lakh only) per proposal
- ii. Post Graduate Paramedical Allied Health Science Courses - Rs.2,00,000/- (Rupees two lakh only) per proposal

5. The Director of Medical Education is directed to take necessary further action accordingly, including the remittance of the fee collected into relevant Personal Deposit Account.
