In the letter read above, the Mission Director, State Health Society has stated that the Government of India have transferred and credited into State Government Account its share of Grants-in-Aid for Flexible Pool for Non - communicable disease under National Health Mission during 2017-18. 3. The corresponding 40% of the State Share against the 60% of the Government of India release of Rs. 10,72,00,000/- (Rupees Ten crore and seventy two lakh only) works out Rs.7,14,66,667/- (Rupees Seven crore Fourteen lakh sixty six thousand six hundred and sixty seven only).

4. The Mission Director, National Health Mission has therefore requested the Government to issue orders for the release of a sum of Rs.17,86,66,667/- (Rupees Seventeen crore eighty six lakh sixty six thousand six hundred and sixty seven only) towards the Release of Grants-in-aid for Flexible Pool for Non-Communicable Diseases during 2017-18 as mentioned above and to authorize the Mission Director, State Health Society and Project Director Reproductive and Child Health Project, Tamil Nadu, to draw a sum of Rs.17,86,66,667/- (Rupees Seventeen crore eighty six lakh sixty six thousand six hundred and sixty seven only) under National Health Mission and credit into State Health Society Account.

The Government after careful consideration have decided to accept the above proposal of the Mission Director, State Health Society and accordingly sanction a sum of Rs.17,86,66,667/- (Rupees Seventeen crore eighty six lakh sixty six thousand six hundred and sixty seven only) towards the Central and State Share contribution of Grants-in-Aid for Flexible Pool for Non-Communicable Diseases during 2017-18 under National Health Mission.
