- 2. The corresponding 40% of the State Share against the 60% of the Government of India release of Rs.18,48,00,000/- (Rupees Eighteen crore and Fourty eight lakh only) works out Rs.12,32,00,000/- (Rupees Twelve crore and thirty two lakh only).
- 3. The Mission Director, National Health Mission has therefore requested the Government to issue orders for release of a sum of Rs.30,80,00,000/- (Rupees Thirty crore and eighty lakh only) towards the release of Grants-in-Aid for Flexible

Pool for Communicable Diseases for the year 2017-18 as mentioned above and to authorize the Mission Director, State Health Society and Project Director Reproductive and Child Health Project, Tamil Nadu, to draw a sum of Rs.30,80,00,000/- (Rupees Thirty crore and eighty lakh only) under National Health Mission .

- 4. The Government after careful consideration accord sanction for a sum of Rs.12,32,00,000/- (Rupees Twelve crore and thirty two lakh only) being State share of Grants-in-Aid for Flexible Pool for Communicable Diseases for the year 2017-18 under National Health Mission.
