**ORDER:-**

In the Government Order first read above, the Government have accorded revised administrative and financial sanction for a sum of Rs.2,36,75,000/- for the construction of Post Mortem Building in Coimbatore Medical College Hospital, Coimbatore.

2. The Engineer-in-Chief and Chief Engineer (Buildings), Chennai Region, Public Works Department, Chennai has sent the revised administrative sanction proposal for the construction of Post Mortem Building in Coimbatore Medical College Hospital, Coimbatore for a sum of Rs.2,36,75,000/- and the details of tender excess and other charges are as follows:-

- 3. The Director of Medical Education has stated that revised estimate is due to tender excess and tender advertisement charges. She has therefore requested the Government to accord administrative sanction for a sum of Rs.2,36,75,000/- for the construction of Post Mortem Building in Coimbatore Medical College Hospital, Coimbatore against the original sanction of Rs.1,82,00,000/-. She has countersigned and forwarded the revised estimate received from the Engineer-in-Chief and Chief Engineer (Buildings), Public Works Department, Chennai.
- 4. The proposal has been cleared by the Technical Advisory Committee constituted in G.O.(Ms) No.146, Public Works Department, dated 12.08.2011 to scrutinize the revised administrative sanction proposal in respect of all technical and financial aspects involved in the work and the Tender Award Committee in its 219<sup>th</sup> meeting held on 01.06.2015 has approved the revised administrative sanction proposal for a sum of Rs.2,36,75,000/- for the construction of Post Mortem Building in Coimbatore Medical College Hospital, Coimbatore against the original administrative and financial sanction of Rs.1,82,00,000/- with an instruction that there should not be any further revised administrative sanction and subject to accuracy, correctness and genuiness of all informative data furnished by the Chief Engineer (Buildings), Public Works Department.
- 5. The Government have examined the proposal of the Director of Medical Education and decided to accept the same. Accordingly, revised administrative sanction is accorded for a sum of Rs.2,36,75,000/- (Rupees two crore thirty six lakh and seventy five thousand only) towards construction of Post Mortem Building in Coimbatore Medical College Hospital, Coimbatore as against the original sanction of Rs.1,82,00,000/- in the Government Order first read above with an instruction that there should not be any further revised administrative sanction and subject to accuracy, correctness and genuineness of all informative data furnished by the Chief Engineer (Buildings), Public Works Department.
- 6. The revised expenditure sanctioned in para 5 above shall be debited to the following head of account:-

"4210 – Capital Outlay on Medical and Public Health – 01 Urban Health Services – 110 Hospitals and Dispensaries (including Pharmacy) – Schemes in the Twelfth Five Year Plan II – State Plan – JA Buildings – 16 Major works". (DPC.4210-01-110-JA-1602)

7. The expenditure sanctioned in para 5 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Buildings) is directed to calculate the actual amount required for the period upto next Supplementary Estimate 2016-2017/Revised Budget Estimate 2016-2017 and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG-I) Department. The Chief Engineer (Buildings) is requested to send necessary explanatory notes to include the

above expenditure in the Supplementary Estimate 2016-2017/Revised Budget Estimate 2016-2017 to Finance Department at the appropriate time without fail.

8. This order issues with the concurrence of Finance Department vide its U.O.No.55/ADS(PU)/Health-II/2016, dated: 03.03.2016 and ASL No.2519 (Two thousand five hundred and nineteen).
