ORDER:

In the Government Order first read above, among others, orders have been accorded for administrative sanction for the work of construction of the Regional Cancer Centre Building at Tirunelveli Medical College Hospital, Tirunelveli for an estimated amount of Rs.300.00 lakhs

2. In the letter second read above the Director of Medical Education as stated that the plan evolved by the Chief Architect vide CA Job No.A.3003/Drg.1 to 4 for the construction of Regional Cancer Centre Building with the total plinth area of 1031 m² were sent to the Atomic Energy Regulatory Board, Mumbai and the same was approved by Atomic Energy Regulatory Board on 25.03.2015. Accordingly, the estimate for the construction of Regional Cancer Centre Building at Tirunelveli Medical College Hospital, Tirunelveli has been prepared and the amount has been worked out to Rs.435.00 lakhs for the year 2015-16 as against the original Administrative sanction amount of Rs.300.00 lakhs. The estimate is prepared based on the current schedule of rate for the year 2015-16 and local market rates and the estimate is worked out to Rs.435.00 lakhs. The Director of Medical Education has also stated that the Atomic Energy Regulatory Board has approved the plan only after one year and 3 months, linear accelerator room 1 & 2 walls at

proposed with 1400mm to 2200 mm RCC and escalation due to change in schedule of rate. Due to the above reasons the cost of Rs.300.00 lakhs has been increased to Rs.435.00 lakhs.

3. Therefore, the Director of Medical Education has requested to issue revised Administrative and Financial Sanction for construction of Regional Cancer Centre Building at Tirunelveli Medical College Hospital, Tirunelveli for an estimated cost of Rs.435.00 lakhs.

4. The Government after careful examination here by accord revised administrative sanction of Rs.4.35 crore (Rupees Four crore and thirty five lakhs only) for the year 2015-16 as against the amount of Rs.3.00 crore originally sanctioned vide G.O.(Ms)No.255, Health & Family Welfare (EAPII.1) Department, dated 01.11.2013 for the construction of Regional Cancer Centre Building at Tirunelveli Medical College Hospital, Tirunelveli. Subject to the condition that there should not be any further revised administrative sanction subject to accuracy, correctness and genuineness of all informative data furnished by the Chief Engineer (Building), Public Works Department, Chennai.

5. The revised expenditure sanctioned in para 4 above shall be debited to the following Head of Accounts:

"4210 - Capital Outlay on Medical and Public Health - 01
Urban Health Service - 110. Hospital and Dispensaries
(including Pharmacy) schemes in the Twelfth Five Year Plan
- II State Plan JA - Building - 16 Major Works.

6. The revised expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Buildings) is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance(BG.I)department directly inform "A" appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance(BG.I)Department. The Chief Engineer(Buildings) is requested to send necessary explanatory notes to include the above expenditure in the Revised Budget Estimate 2016-2017 Supplementary Estimates for the year 2016-2017 to Finance Department at the appropriate time without fail.
