#### ORDER:

In the Government Order first read above, the Government accorded sanction for implementation of Non-Communicable Diseases Intervention program in all the districts in Tamil Nadu.

2. In the Government Order second read above, the Government ordered that the evaluation of the programme in all districts be taken up by the National Institute of Epidemiology, Chennai.

3. In the Government Order third read above, the Government ordered that community based Non Communicable Diseases intervention activities be implemented in collaboration with Tamil Nadu Corporation for Development of Women and Tamil Nadu Pudhu Vazhvu Project by utilizing the services of Community Resource Persons /Community Persons for sensitizing the Self Help Groups women on Non communicable diseases.

4. The Project Director, Tamil Nadu Health Systems Project, has reported that the baseline survey for community based Non Communicable Diseases intervention programme was conducted by the National Institute of Epidemiology to assess the awareness related parameters prior to launch of community based SHG training activities, that the Stage III sensitization of Self Help Groups is being carried out from 16.06.14 onwards until Aug '14 and that it has been decided to conduct end line survey in Villupuram district, where baseline survey was done earlier. For this purpose the Project Director, Tamil Nadu Health Systems Project had placed a proposal before the State Empowered Committee in the meeting held on 01.08.2014 for sanction of an additional amount of Rs.5,33,710/- for conducting end line survey on the Non Communicable Diseases intervention programme. The State Empowered Committee had approved the proposal. The Project Director has requested the Government to issue orders in the matter.

5. This activity has been approved by the World Bank and comes under Component I and Sub-component C. The expenditure is eligible for reimbursement from the World Bank.

6. The Government after careful consideration accord sanction for incurring an expenditure of Rs.5,33,710/- (Rupees five lakh thirty three thousand seven hundred and ten only), to meet the expenditure connected with the conducting of end line survey on the Non Communicable Diseases intervention programme in Villupuram district.

7. The Government also direct that out of the cost of Rs.5,33,710/-, a sum of Rs.1,39,612/- shall be met from out of the existing contract value of Rs.3,05,62,760/- already sanctioned and the remaining amount of Rs.3,94,098/- shall be met from out of the savings available under the Housekeeping services component under the following head of account.
