Chief Minister's Comprehensive Health Insurance Scheme – Sanction of amount of Rs.26,93,942/- (Rupees Twenty Six Lakh, Ninety Three Thousand, Nine Hundred and Forty Two only) excluding Rs.19,79,000/- to be released by UIIC from corpus fund under Chief Minister's Comprehensive Health Insurance Scheme towards the consumables cost for the Flow Divertor Stent procedure to be done to 4 CMCHIS beneficiaries – Sanctioned - Orders- Issued.

ORDER:

In the letter read above, the Project Director, Tamil Nadu Health Systems Project has stated that four patients viz.Tmt.Selvamary, 52/F, Tmt.Bhuvaneshwari, 32/F, Tmt.Sumathy, 41/F and Thiru.Vasu, 56/M from TamilNadu Government Multi Super Specialty Hospital, Omandurar are suffering from intracranial Aneurysm that warrants Flow Diverter Stenting. All the 4 patients are Chief Minister's Comprehensive Health Insurance Scheme beneficiaries. Even though the procedure is covered under Chief Minister's Comprehensive Health Insurance Scheme it unviable to perform as the consumables cost are extremely high.

2. The Project Director, Tamil Nadu Health Systems Project has stated that the Director, Tamil Nadu Government Multi Super Specialty Hospital, Omandurar requested him to sanction Rs.46,72,942/- (Rupees Forty Six Lakh Seventy Two Thousand Nine Hundred and Forty Two) only towards the consumables cost for the Flow Diverter Stent procedure to be done to the 4 CMCHIS beneficiaries from CMCHIS corpus fund.

3. The Project Director, Tamil Nadu Health Systems Project has stated that the Project Manager, CMCHISTN, UIIC had agreed to sanction the maximum available sum insured up to Rs.5 lakh over and above the package cost of Rs.95,250/-. The balance amount of Rs.26,72,942/- (Rupees Twenty Six Lakh Seventy Two Thousand Nine Hundred and Forty Two) only excluding Rs.5 Lakh each for the 4 cases to be released by UIIC or the balance amount other than the maximum sum insured available released by UIIC may be sanctioned from CMCHIS corpus fund.

4. The Project Director, Tamil Nadu Health Systems Project has stated that as on 1.11.2019, the balance sum insured available for the 4 CMCHIS beneficiaries are detailed below:

5. The Project Director, Tamil Nadu Health Systems Project has stated that excluding the sum insured available amount of Rs.19,79,000/- from the requested amount of Rs.46,72,942/- an amount of Rs.26,93,942/- has to be sanctioned from CMCHIS corpus fund.

6. The Project Director, Tamil Nadu Health Systems Project has clarified as follows:

- i. Package Costs for the procedures under CMCHIS have been fixed before the start of implementing the scheme for second term from 11.01.2017 with the advice of the DME and HODs of Government Medical College Hospitals.
- ii. The Package costs could not be revised in the middle of the tender period. Revision can be taken only in the new tender which begins from January 2022.
- iii. In the Package of Flow Divertor Stent the package rate may increase depending upon the usage of more stents required by the particular patient / beneficiary. This has to be dealt on a case to case basis only.

7. The Project Director, Tamil Nadu Health Systems Project has requested the Government to issue special orders on the followings:-

- i. To sanction an amount of Rs.26,93,942/- (Rupees Twenty Six Lakh, Ninety Three Thousand, Nine Hundred and Forty Two only) excluding Rs.19,79,000/to be released by UIIC from corpus fund under Chief Minister's Comprehensive Health Insurance Scheme towards the consumables cost for the Flow Divertor Stent procedure to be done to the 4 CMCHIS beneficiaries mentioned at para 4 above.
- ii. To sanction any additional amount utilized from the available amount during the course of time before doing the Flow Diverter Stent procedure from the CMCHIS corpus fund.

8. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health Systems Project have decided to accept the same and accordingly sanction an amount of Rs.26,93,942/- (Rupees Twenty Six Lakh, Ninety Three Thousand, Nine Hundred and Forty Two only) excluding Rs.19,79,000/- to be released by UIIC from corpus fund under CMCHIS towards the consumables cost for the Flow Divertor Stent procedure to be done to the four(4) beneficiaries of Chief Minister's Comprehensive Health Insurance Scheme as detailed at para 4 above.

9. This order issues with the concurrence of the Finance Department vide its U.O.No.59011/Health-II/2021, Dated: 04.01.2022.
