ORDER:

The Chairman/ Mission Director, i/c., National Health Mission in the reference 13th read above has stated that in the reference 1-11, the Government issued funds

releasing order for various schemes under National Health Mission in the ratio of 75:25 pattern. He has further stated that the Govt of India have stated that a decision has been taken for revision in sharing pattern under NHM to 60:40 from the Financial Year 2015-16 onwards.

2. In this connection, he has submitted that the 25% State Share of Rs.182,85,04,335/- has already been drawn for the 75% Govt of India Share of Rs.548,55,13,000/- in the Govt. Orders mentioned above. Since the Govt. of India, have revised the Sharing Pattern as 60:40, the difference of of State Share Rs.182,85,04,335/-is now proposed for the claim of State Share as detailed below by taking the Govt. of India release as 60% and to arrive the corresponding State Share as 40/60.
