ORDER:-

In the letter read above the Director of Medical and Rural Health Services has stated that the Government Taluk Hospital, Kattumannarkovil, Cuddalore District is functioning with 44 sanctioned bed strength as Taluk Hospital. An average of 670 out-patients and 40 in-patients are treated per day at this hospital. He has also stated that there is only one Pharmacist post sanctioned to this hospital. The routine works i.e. disbursing drugs to the out-patients and the in-patients, attending post mortem with the Doctors, looking after the maintenance of surgical stores and medical stores, Registering the distribution of drugs in the appropriate register, preparing the condemnation proposals, arrangements of local purchase of medicines etc., are carried out by this only Pharmacists, it is very difficult to face the routine hospital works with handling of drugs and other related above mentioned Pharmacy works. He has also stated that as per the medical code norms the above Hospital has to be sanctioned with minimum strength of 5 Pharmacists.

2. The Director of Medical and Rural Health Services has requested the Government to sanction one new additional Pharmacist post to the Government Taluk Hospital, Kattumanarkovil, Cuddalore District for the uninterrupted and smooth functioning of the above Hospital.

3. The Government after careful examination, accord sanction for creation of one post of Pharmacist in the time Scale of Pay 9300-34800 + G.P 4200 to the Government Taluk Hospital, Kattumanarkovil, Cuddalore District at an average annual recurring cost of Rs.7,07,850/- (Rupees Seven Lakh Seven Thousand Eight Hundred and Fifty only) for a period of one year from the date of filling up of the post .

4. The expenditure sanctioned in para 3 above shall be debited to the following Head of Account:-

"2210 - Medical and Public Health – 01-Urban Health Services - Allopathy- 110 – Hospitals and Dispensaries -- I Non - Plan AB Taluk Headquarters Hospitals - 01 Salaries".
