In the letter read above, the Mission Director, State Health Society has stated that the Government of India have transferred and credited its share into Government of Tamil Nadu account being the Flexible Pool for Communicable Diseases under National Health Mission for the year 2017-18 as detailed below:-

2. The corresponding 40% of the State share against the 60% of the Government of India share of Rs. 6,27,00,000/- is worked out to Rs.4,18,00,000/-.

The Mission Director, State Health Society has therefore requested the Government to issue orders for the release of a sum of Rs.10,45,00,000/- (Rupees ten crore and forty five lakh only) being the State and Central Share contribution of Grants-in-Aid to the Flexible Pool for Communicable Diseases under National Health Mission for the year 2017 - 2018 as mentioned above and to authorize him to draw the above amount credit it into State Health Society Account.

4. The Government after careful consideration has decided to accept the above proposal of the Mission Director, State Health Society and accordingly sanction a sum of Rs.10,45,00,000/- (Rupees ten crore and forty five lakh only) being the State and Central Share contribution towards Grants-in-Aid for Flexible Pool for Communicable Diseases under National Health Mission for the year 2017 – 2018.
