ORDER:

1. In the Government order first read above orders have been issued for sanctioning the Government sanctioned a sum of Rs.1.20 Crores being the 20% Share of the State Government . Under the Scheme to the Government General Hospital, Chennai for construction of the building to house the Linear Accelerator under Tertiary Cancer Centre Scheme under National Programme for prevention and Control of Cancer, Diabetes and Cardio – Vascular Diseases and Strokes (NPCDCS) .

2. In the letter second read above, the Director of Medical Education has stated that as per the request of Dean Government General Hospital, Chennai to include 15 MV Linear Accelerator room number. 2 front portion of room numer.2 with Chiller room, electrical room, technical room, the rough cost estimate has been prepared with 260.47 Sq.m which have only been considered as against the approved area of 397.80 Sq.m by the AERB for the above work and based on that, the amount has been worked out to Rs.1.73 Crores for the year 2013-14 by adopting the current schedule of rates and Rs. 1.903 Crores for 2014-2015 by adding 10% escalation cost.

3. Therefore, the Director of Medical Education has requested to Government to issue revised Administrative sanction of Rs. 1.903 Crores for the year 2014-2015 over and above the estimated cost sanctioned vide G.O (Ms.)No.279, Health and Family Welfare Department, dated: 22.03.2013 for construction of building for housing 15 MV Linear Accelerator in Radiation oncology Block in Rajiv Gandhi Government General Hospital, Chennai.

4. The Government, after careful examination, hereby accord the Revised Administrative Sanction of Rs. 1,90,30,000/- (One Crore Ninety Lakhs and Thirty Thousand only) for the year 2014-15, including 10% cost escalation, as against the

expenditure sanctioned in the G.O first read above , for the construction of Radiation Oncology Block 15 MV Linear Accelerator room No.2 and Part of front Portion, Side Portion for Rajiv Gandhi Government General Hospital, Chennai . Subject to the condition that, there should not be any further Revised Administrative Sanction and to the accuracy, correctness and genuineness of all informative data furnished by the Chief Engineer (Buildings), Public Works Department, Chennai.

5. The expenditure sanctioned in para 4 above shall be debited in the following head of account:-

“ 4210 – Capital Outlay on Medical and Public Health -01-Urban Health Services -110 – Hospitals and Dispensaries (including Pharmacy) - Schemes in the Twelfth Five year Plan –II State Plan – JA – Buildings - 16 Major Works. (DPC: 4210-01-110-JA-1602)

6. The expenditure sanctioned in para 4 above shall constitute an item of New Instrument of Service” and the approval of legislature will be obtained in due course pending approval of legislature the expenditure will be initially met by an advance from the contingency fund. Orders for sanction of an advance from the contingency fund will be issued by the Finance (Budget-I) Department. The Chief Engineer (Building) shall apply for sanction of advance from contingency fund for the amount required upto March 2015 in the prescribed format along with a copy of this order to Finance (Budget –I) Department. The Chief Engineer (Building) shall also send necessary explanatory notes to include the above expenditure in the Supplementary Estimate for the year 2014-2015 to Finance Department at the appropriate time without fail.
