ORDER:

The Project Director, Tamil Nadu Health Systems Project has reported that the Government has initiated the quality Assurance Programme on Accreditation of selected Government Hospitals through National Accreditation Board for Hospitals and Health Care Providers (NABH) to improve the quality of care in Secondary Care Government Hospitals in Tamil Nadu, that initially as a pilot programme, 12 hospitals have been selected for getting accreditation status under National Accreditation Board for Hospitals and Health Care Providers (NABH), Quality Council of India (QCI), New Delhi, that out of 12 Secondary Care Government Hospitals, which have applied for NABH, three hospitals have achieved Accreditation Board for Hospitals and Health Care Providers certification and three hospitals completed the Final Assessment and that the remaining 6 hospitals are in the pipe line for Final Assessment. In order to reinforce the accreditation activities, the Project Director, Tamil Nadu Health Systems Project, has proposed to conduct continuous review cum workshop and in house training for the officials involved in accreditation process, which is essential to sustain the accreditation status and quality services in the long run.

2. For the above purpose, the Project Director, Tamil Nadu Health Systems Project had placed a proposal before the State Empowered Committee in the meeting held on 01.08.2014 for sanction of Rs. 49.50 lakhs towards conducting review cum workshop on accreditation at regional level for officials & staff of secondary care hospitals by Tamil Nadu Health Systems Project, organizing Pre Assessment, Final Assessment, Surveillance visit by Tamil Nadu Health Systems Project in selected hospitals, payment of Annual fees to Quality Council of India, Pol training programme to be conducted by the Quality Council of India, New Delhi

and conducting of in house training in 20 accreditation hospitals. The State Empowered Committee had approved the proposal. The Project Director has requested the Government to issue orders in the matter.

3. This activity has been approved by the World Bank and comes under Component III and Sub-component B. The expenditure is eligible for reimbursement from the World Bank.

4. The Government after careful consideration accord sanction for incurring an expenditure of Rs. 49.50 lakh (Rupees forty nine lakh and fifty thousand only) (Non Recurring Rs.40,50,000.00 + Recurring Rs.9,00,00,000) towards conducting review cum workshop on accreditation at regional level for officials & staff of secondary care hospitals by Tamil Nadu Health Systems Project, organizing Pre Assessment, Final Assessment, Surveillance visit by Tamil Nadu Health Systems Project in selected hospitals, payment of Annual fees to Quality Council of India, Pol training programme to be conducted by the Quality Council of India, New Delhi and conducting of in house training in 20 accreditation hospitals as detailed in the annexure to this order.

5. The Project Director, Tamil Nadu Health System Project is permitted to alter the activities and the expenditure within / across the components without exceeding the total amount sanctioned.

6. The Project Director, Tamil Nadu Health System Project is permitted to select the District Head Quarters Hospitals and other hospitals for the workshop on Accreditation depending upon their performance.

7. The expenditure sanctioned in para 4 above shall be debited to the following head of account:
