ORDER:

In Government order first read above, sanction was accorded to a sum of Rs.12,32,00,000/- being the State share of Grants - in - Aid for the flexible pool for communicable diseases under National Health Mission for the year 2017-18.

2. In the letter second read above, the Mission Director, State Health Society has stated that necessary Proposals have been submitted to Government for the release of Government of India share together with State share the flexible pool for communicable diseases for the year 2017-18 for a sum of Rs.30,80,00,000/- as detailed below:-

- 3. In the Government order first read above, sanction was accorded for a sum of Rs. 12,32,00,000/- only being State share of contribution instead of the proposed amount of Rs.30.80 crore being the both Central and State share contribution of Grants in Aid.

The Mission Director, State Health Society has therefore requested the Government to issue necessary orders for the release of a sum of Rs.18.48 crore (Rs.30.80 crore Rs. 12.32 crore) being the Central share contribution of Grants in aid for the communicable diseases for the year 2017-18, since necessary funds have been provided in the Final Modified Appropriation 2017-18 under the relevant Head of Account.

- 5. The Government after careful consideration sanction a sum of Rs.18,48,00,000/- (Rupees Eighteen crore and forty eight lakh only) being the Central Share of Grants - in - Aid to the flexible pool for Communicable Diseases under National Health Mission for the year 2017-18.
- 6. The above item of expenditure is debitable under the following Head of Account:-

- 7. Necessary funds are available in the Final Modified Appropriation 2017-18. The Mission Director, State Health Society is authorised to draw and disburse the amount mentioned in para 5 above and to credit it into State Health Society Account.
