ORDER :

During the Budget discussion held in the Tamil Nadu Legislative Assembly 2014-2015, it has been announced, among others, that a Government Medical College will be established at Karur District as there is no Government or Private Medical College in that District.

2. The Government, after considering the growing demand of meritorious students of the State for Professional Medical Courses, have decided to start a new Government Medical College at Karur District from the academic year 2016-2017.

3. The Government accordingly issue the following orders:

(i) A new Government Medical College shall be established at Karur District with an annual intake of 150 students from the academic year 2016-2017.

(ii) Sanction is accorded for creation of one post of Special Officer-cum-Dean in the scale of pay Rs.37,400-67,000+8,800 Grade Pay to attend the initial work relating to the establishment of a new Government Medical College at Karur District for a period of one year from the date of employment. The holder of the posts is eligible to draw Dearness Allowance, House Rent Allowance and other allowances applicable as per rules.

(iii) orders in respect of land, building, hospital equipments, furniture and staff, etc. will be issued separately on receipt of the report of the Director of Medical Education.

4. The Director of Medical Education is directed to send proposal for issue of Essentiality Certificate, application and time bound action programme to Government immediately so as to send to the Government of India / Medical Council of India within

due date for starting new Government Medical College at Karur District from the academic year 2016-2017.

5. The Director of Medical Education is also directed to take appropriate action to assess the requirements of necessary infrastructure such as land building, equipments, furniture, staff, etc., and send necessary proposal to the Government at the earliest.

6. The expenditure in respect of the post sanctioned in para 3(ii) above shall be debited under the following New Head of Account opened under Demand No.19-03

"2210 Medical and Public Health 05 – Medical Education, Training and Research 105 Allopathy – I Non-Plan CB - Government Medical College, Karur – 01 – Salaries."

7. The Director of Medical Education is the estimating, reconciling and controlling authority for the above said new Head of Account.

8. The Pay and Accounts Officer / Treasury Officer is directed to open the above new Head of Account in their books.

9. The expenditure sanctioned in para 3 (ii) above is an item of "New Service". The approval of the Legislature will be obtained in due course pending approval of the legislature, the expenditure will be initially met by sanction of an advance from the contingency Fund, order regarding which will be issued by the Government in Finance (BG-I) Department separately, the Director of Medical Education is requested to send necessary proposal to Government in Finance (BG-I) Department in the prescribed format along with a copy of this order for sanction of an advance required for the current year from contingency Fund. The Director of Medical Education is also requested to send a draft explanatory notes for including the above expenditure in the Supplementary Estimate 2014-15 to Government in Finance Department without fail.

10. This order issues with the concurrence of Finance Department vide its U.O. No.3280 / CMPC / 2015, dated 19.01.2015 and ASL No.2212 (Two Thousand Two Hundred and Twelve).
