ORDER:

The Director of Public Health and Preventive Medicine in the letter 1st read above, has stated that office of the Deputy Director (Health Services)Villupuram is functioning in rental building without adequate facilities. During the Joint visit of Director of Public Health and Preventive Medicine and Director of Medical and Rural Health Services in the Government Hospital Campus, Villupuram there is an unutilized RMO quarters in a total area of 27,890sq. ft. (or) 0.64 acres of empty land. That area is apt for construction of the Deputy Director (Health Services) Office buildings. The Director of Public Health and Preventive Medicine has therefore requested the Government to transfer the above said unutilized RMO quarters alongwith empty land from Director of Medical and Rural Health Services to Director of Public Health and Preventive Medicine for the utilization of office buildings for Deputy Director (Health Services) office, Villupuram. In this regard, the Director of Medical and Rural Health Services in his letter 2nd read above, has informed that, he has no objection to transfer the above said buildings and land to Director of Public Health and Preventive Medicine.

2. After a detailed examination, the Government have decided to accept the proposal of Director of Public Health and Preventive Medicine

based on the no objection certificate given by Director of Medical and Rural Health Services and issue an order for transfer the unutilized RMO quarters along with 27,890 sq. ft. (or) 0.64 acres of empty land from the control of Director of Medical and Rural Health Services. The land details are as follows:-
