## ORDER:-

In the letters read above, the Director of Medical and Rural Health Services has stated that in order to reduce maternal and infant mortality and morbidity and to render effective maternal health care delivery and to render acute health care to the new born babies, the Comprehensive Emergency Obstetric and New Born Care (CEmONC) centres have been established in the secondary care hospitals under his control as follows:

- 61 CEmONC Centres
- ❖ 44 EmONC Centres
- 64 NICU Centres
- 114 New Born Stabilization Centres.
- 2. The Director of Medical and Rural Health Services has justified that the Joint Director of Health Services (CEmONC) is very essential since the District Officers are already engaged in various assignments to look after and to attend various meetings relevant to smooth running of day to day administration and unable to pay complete attention to look after the performance of the CEmONC centres and their related services.
- 3. The Director of Medical and Rural Health Services has therefore requested the Government to create one post of Joint Director of Health Services (CEmONC), by upgrading one Chief Civil Surgeon post already in existence to look after the Comprehensive Emergency Obstetric and New Born Care (CEmONC) activities exclusively in the Hospital under his control.

- 4. The Government have examined the proposal of Director of Medical and Rural Health Services and accord sanction to create one post of Joint Director of Health Services (CEmONC) in the scale of pay of Rs.37400-67000+GP Rs.8700 in the Directorate of Medical and Rural Health Services by upgrading one existing post of Chief Civil Surgeon which was sanctioned in G.O.No.1064, Health and Family Welfare Department, dated 09.06.1987 and upgraded as Senior Civil Surgeon in G.O.No.684, Health and Family Welfare Department, dated 18.12.1998 and upgraded as Chief Civil Surgeon in G.O.(Ms) No.354, Health and Family Welfare Department, dated 23.10.2009 at Government Head Quarters Hospital, Kancheepuram to look after the Comprehensive Emergency Obstetric and New Born Care (CEmONC) activities.
- 5. The expenditure sanctioned in the para 4 above shall be debited in the following head of the account.

"2210-Medical and Public Health — 01-Urban Health Services - Allopathy- 110 — Hospitals and Dispensaries - I Non-Plan AA Headquarters Hospitals - 01 Salaries". (DPC 2210-01-110-AA-0104)
