## **ORDER:-**

- 5. creation of posts to Theni Medical College, Theni, Chengalpattu Medical College, Chengalpattu and KAP Viswanatham Medical College, Trichy as detailed below:-

The Director of Medical Education is directed to calculate the actual amount required for the period upto next Supplementary Estimate 2016-2017/Revised Budget Estimate 2016-2017 and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG-I) Department. The Director of Medical Education is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimate 2016-2017/Revised Budget Estimate 2016-2017 to Finance Department at the appropriate time without fail.
- 9. The Director of Medical Education is directed that the amount sanctioned for equipment shall not be paid in cash but credited to the following Personal Deposit Account of Tamil Nadu Medical Services Corporation Limited:-
