2. The Government, after careful examination of the proposal of the Director of Medical Education, accord sanction for seven posts (five posts in time scale of pay and two posts in consolidated pay) for the Dispensary functioning in the Madurai

Bench of Madras High Court, Madurai at a total cost of Rs.40,02,420/- (Rupees Forty lakh two thousand four hundred and twenty only) per annum as detailed below:-

(i) five posts in the time scale of pay on permanent basis at an average cost of Rs.38,34,420/- (Rupees Thirty eight lakh thirty four thousand four hundred and twenty only) per annum as follows:-

(ii) two posts on consolidated pay to be filled through outsourcing at a cost of Rs.1,68,000/- (Rupees One lakh and sixty eight thousand only) per annum as follows:-:-

3. The expenditure towards pay and allowances of posts sanctioned in para 2 above shall be debited to the following head of account:-

"2210 – Medical and Public Health – 05 – Medical Education, Training and Research – 105 Allopathy - I Non Plan AD – Madurai Medical College, Madurai – 01 Salaries." (DPC 2210 – 05-105- AD - 0107)

"33 Payments for Professional and Special Services – 04 Contract Payment." (DPC 2210-05-105-AD-3346)

4. The expenditure sanctioned in para 3 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director of Medical Education is directed to calculate the actual amount required for the period upto next Supplementary Estimate 2016-2017/Revised Budget Estimate 2016-2017 and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form A appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Director of Medical Education is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimate 2016-2017/Revised Budget Estimate 2016-2017 to Finance Department at the appropriate time without fail.
